SUMMARY

COMMUNITY RISK ASSESSMENT & STANDARDS OF COVER

- 1. Defines risk by service type (fire, EMS, tech rescue, HAZMAT, wildland) for each of the 9 planning zones
- 2. Establishes Performance
 - Baselines are historical performance (total of 40)
 - Benchmarks are performance goals (total of 40)
- 3. Levels of Service: Critical Task Analysis ensure compliance to SOGs, firefighter safety, and efficient use of resources
- 4. Performance Gaps:
 - PZ6: Cobblestone Ranch, Liberty Village
 - PZ7: South/East portions of district: Stone Cañon Ranch, Lake Gulch Road area
 - PZ8: Dawson Ridge, Keene Ranch, Twin Oaks

2021 COMMUNITY RISK ASSESSMENT

RECOMMENDATIONS

- 1. Actively participate with other Town departments in the development and planning phases to ensure and plan for fire and emergent responses.
- 2. Consider an expanded hazardous materials commodity flow study that provides a more comprehensive overview of the materials being transported through the jurisdiction

- 3. Develop a sustainable methodology to ensure all new and updated commercial occupancies are evaluated using the OVAP model and ensure significant or special risk facilities are easily identified for response personnel.
- 4. Consistent with 2020-2024 Strategic Goal 2020-03, adopt the CWPP – **COMPLETE**

2021 STANDARDS OF COVER

RECOMMENDATIONS

- 1. Review, research and attempt to determine the root cause for the increased 1st arrival response times in Planning Zone 2 (PZ2).
- 2. Closely monitor PZ6 for growth, increasing calls for service and performance.
- 3. Closely monitor PZ9 for growth, increasing calls for service and performance.

- 4. Monitor actual and potential growth in PZ8
- 5. Adopt the updated benchmarks for the 2022-2026 evaluation cycle.
- Provide updates to the Public Safety Commission, Town Manager and Town Council on a monthly and annual basis.
