COUNCIL COMMENTS

Mayor Gray acknowledged the Town's great events and strong participation from residents. He encouraged honoring the people and moments in our lives especially when losing family members, helping friends in dire straits and the love of friends and family.

Councilmember Dietz reported that the Kum and Go gas station is not pursuing the Crystal Valley location. He encouraged the honoring of our veterans as D-Day/Remembrance Day was on Mon., June 6.

Councilmember Johnson encouraged residents to attend the Town Hall for budget discussion that is being held in person and online.

Councilmember LaFleur had a CBD manufacturing company reached out to her in their local efforts to help with mental health issues and the manufacturing of medical marijuana products.

Mayor Pro Tem Bracken expressed his concern with the lack of effective communication regarding the homeless shelter. Staff has not received a response from Douglas County Commission from the letter written opposing the building of a shelter in the Castle Rock area. Town Manager Corliss reported that the Douglas County Commission is discussing panhandling.
