### 2024 – 2028 BUDGET CONSIDERATIONS & STRATEGY

- Growth Forecast
  - ✓ 1,560 fewer Residential permits in 2023-2027 vs last year budget
  - ✓ SDF revenue decrease of approximately \$35M during this timeframe
- Maintain Water Capital Plan
  - ✓ Annual inter-fund loans from Wastewater to Water from 2024-2028 ~\$28M
  - ✓ Temporary reduction of catastrophic failure reserve from 2% 1%
  - ✓ Catastrophic failure reserve still \$9.8M over all 4 funds
  - ✓ Improve peak demand capacity
- Continue Reduced Stormwater Capital Plan
  - ✓ Temporary reduction of catastrophic failure reserve from 2% 1%

## 2024 – 2028 BUDGET CONSIDERATIONS & STRATEGY

- Additional Revenue Bonds
  - √ \$40M anticipated in Water Resources in 2026
  - ✓ Debt ratio of 10% today, top AWWA quartile is <25%
  - ✓ New debt ratio of 14% with anticipated bond, still in top AWWA quartile
- Use of Rate Revenue Stabilization and Catastrophic Failure Reserve for 2023
  - ✓ \$3.5M \$4.0M
  - ✓ Reimburse reserves in 2024-2028
- Review / Reduction of Operating Expense Budget




#### WATER PROVIDER COMPARISONS
