Dear Mr. Corliss, Ms. Muller and Town Council,

2021 is a year of celebration for us as we are turning 50 years young. The Castle Rock Senior Activity Center (CRSAC) began in 1971 as a seniors club. It was incorporated in 1992 and has evolved into a community senior activity center designed to meet the needs of those age 50 and over serving more than 1000 members and 375+ registered riders in our transportation program alone. The Center provides services and programming to help older adults "age in place" and live independent and fulfilled lives. With a fleet of vehicles and a team of dedicated volunteers, more than 750 rides pre-COVID and currently just over 500 rides are provided each month to doctor's appointments, grocery stores and other quality of life locations.

We also provided more than 160+ activities monthly prior to the pandemic, however currently with the center closed to "in-center" programing we are offering over 25+ virtual, parking lot and take home activities and programs scheduled monthly, with more added as resources & weather allow. We have begun bringing "incenter" programs and activities back this month and hope to start trips and outings again by August. We plan to have all the past educational, social, health and recreational programs, along with many new ones developed over this past year. We plan to continue our Center's wonderful environment as the place to meet people and explore a variety of options to stay active and involved as this is more important than ever as we emerge from the pandemic. In 2022, we project to be at the former service levels, if not higher as we were trending that way in 2019.

Through our partnership with Volunteers of America, we serve as a nutritional meal service site, and are the coordinating site for the Douglas County Meals on Wheels Program. This is very important, as the number of homebound residents needing this service continues to grow during the pandemic and we shifted our dining clients to a curbside pickup or delivery service. We will be bringing back the "In-center" dining program in August, along with continuing the "to-go" option for those older adults still wanting a hot meal, but not yet comfortable with the in-person dining.

The CRSAC is able to utilize volunteers in many ways to help offset expenses and help our funding stretch. With over 450 volunteers donating their talents, whether it's helping drive in our transportation program, working at the front desk, answering phones or serving at our hot lunch program to name just a few of our volunteer opportunities. In 2020, 15,748 hours were donated. This is the equivalent to 8 full time employees, and is about half of what we do in a pre-pandemic year. These dedicated volunteers donated their time to help us provide crucial services and programs to the most vulnerable populations affected. In 2022, we expect to see over 30,000 hours donated again as we bring back all of our programs, activities and events, along with many new ones.

By this donation of volunteerism, other grants and fundraising, and with support from the town, we are able to offer a level of service that is unmatched by other Centers.

The Castle Rock Senior Center continues to strive to be a leader in helping seniors, and their families, and values the communities it serves. While we were unable to hold our Annual Senior Life Expo in 2020, it is planned for June 30<sup>th</sup>, 2021 at the DC Event Center from 1-5pm. This event has proven to be a leading event to the community that addresses resources and provides information about ways to love life in the second half. We know this event is very important to both attendees and businesses, as they are able to help many older adults on that day and connect for future needs. We know that it is critical for seniors to be aware of the services available to them, and we plan to continue to be a leader for providing communication and information to the senior population. The Center loves to partner with other community organizations by donating our volunteers and staff to help with community events including the Town of Castle Rock, Castle Rock Parks and Recreation, the Merchant's Association, local service organizations, (Kiwanis, Rotary, and Civitan) and the Chamber of Commerce.
