<u>Motion</u>: (6:31 p.m.) Commissioner Townsend moved to recommend that Town Council approve an Ordinance Amending Section 17.04.040 of the Town of Castle Rock Municipal Code requiring that applicants conduct neighborhood meetings with condition that the 1st paragraph be amended with better clarifying language to remove any possible conflict between 1st paragraph and subsequent paragraphs. B. <u>A Resolution Approving the Hillside/Arbors Site Development Plan</u> (6:32 p.m.) Ferguson: Site Development Plan for a 120-unit gated, residential community for seniors 55 and older.

Commissioner Townsend seconded the motion.
