



PROPOSED NEW HOPE SUBDIVISION











PROPOSED FAITHFUL FOLLOWERS PRESCHOOL




- Pre-application no formal submittal at this time




5-1 19740 1800 PA-C2 & PA-D LOTTING PLAN AREA
