

RESOLUTION NO. 2026-044

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF
CASTLE ROCK APPROVING THE RENAMING OF PRAXIS STREET
TO ATCHISON WAY AND BRICKYARD LANE**

WHEREAS, Praxis Street is a new roadway that is wholly located within the Town of Castle Rock (the “Town”) and Douglas County (the “County”) on the west side of Interstate 25; and

WHEREAS, this roadway, which is under construction, will provide public access from Plum Creek Parkway to the Town’s new Sports Development Center, also under construction; and

WHEREAS, it is anticipated, however, that Praxis Street will be extended to the north at some point in the future, eventually connecting with the existing Atchison Way; and

WHEREAS, for this reason, Town staff is initiating the process of renaming Praxis Street as Atchison Way; and

WHEREAS, renaming Praxis Street to Atchison Way aligns with the long-term vision for Atchison Way as a continuous north-south corridor as identified in the Town’s Transportation Master Plan; and

WHEREAS, establishing a continuous street will reduce confusion for residents, visitors, and emergency responders as this corridor develops; and

WHEREAS, because no addresses have yet been assigned along Praxis Street, the renaming can occur without any impact to existing property owners or businesses; and

WHEREAS, in addition, a small east-west bend in the roadway will be renamed as Brickyard Lane, thereby reinforcing the identity of the Brickyard development area and providing logical, intuitive navigation within that site; and

WHEREAS, in accordance with established Town and County policy, Town staff has submitted a formal referral request to the County Planning and Addressing office, identifying the names being proposed for the street; and

WHEREAS, County staff has determined that the new names are consistent with Town and County standards and do not conflict with any existing street names; and

WHEREAS, the Town Council finds and determines that the renaming of Praxis Street as Atchison Way and Brickyard Lane is in the best interests of the Town and its residents.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF CASTLE ROCK, COLORADO AS FOLLOWS:

Section 1. Approval. The Town Council hereby authorizes Town staff to take whatever actions may be necessary to rename Praxis Street as Atchison Way and Brickyard Lane as depicted on the map presented at tonight's meeting.
