
Call Statistics:

For the month of June 2015 we responded to 444 calls for service. Last year at this time we responded to 357 calls. This places our year to date calls at 213 ahead of last year at this time.

Of the 444 calls for service, 272 of the calls were for EMS. We had a total of 239 patient contacts and transported 183 patients. This time last year we had 166 transports.


The pie chart and graph below indicates calls for the month, not the overall year:

Total Incidents by Category




EMS Calls:

The most common EMS call in June was for dizziness with 21 patients. The second most common was for neck or back pain with 20 patients.



For the month of June, 42 patients were transported to Sky Ridge, which is 22.9% of all patients transported, and 130 patients were transported to Castle Rock Adventist, which is 71% of all patients transported.

Fire Calls:

During the month of June we ran 2 fire calls compared to 10 last year. We had 42 alarm calls compared to 35 last year at this time. The rainfall contributed to the decrease in fire calls.

Key Operational News:

Significant incidents are on each individual shift report. We did experience some calls due to the amount of rainfall received, but no major incidents occurred as a result of the flooding.

Special event season is in full swing, and we are covering a number of events. We are also seeing an increase in public visits at Station 151 as people are downtown for events like Movie Night, the Car Show, etc.

Significant Incidents for June:

A Shift: Nothing to report

B shift: Nothing to report

C Shift: On June 8, at 9:15 PM, Engine and Medic 153, and Battalion 151, responded to Castlewood Ranch on a reported cardiac arrest. On arrival, CPR was being performed by Castle Rock Police Department. Advanced Life Support measures were initiated and the patient regained pulses and was transported to Castle Rock Adventist Health Center.

The patient was transferred to Porter for further definitive care. The patient had a complete recovery and was discharged home.

On June 21, at 6:14 PM, Battalion 151, Quint 155, and Medic 154, responded to Sapphire Point on a cardiac arrest. Resuscitation efforts were attempted, however, the patient expired. The scene was left with CRPD.

On June 26, at 12:23 AM, Battalion 151, Quint 155, Medic 154, and Chief 154 responded to Lemon Gulch on a reported cardiac arrest. On arrival, the patient had been expired long enough to where resuscitation efforts were not indicated. The scene was left with Douglas County Sheriff's Office.

2nd Quarter Explorer Report

The 2nd quarter has been full of changes and success. With the end of the school year, we have both gained and lost explorers. We currently have 16 Explorers in the post. We lost 3 at the end of the school year, but gained 4 new recruits in the past few weeks.

The Explorers participated in a large-scale mock disaster hosted by Arapahoe County with South Metro Fire and multiple law enforcement explorers. The explorers used multiple skills throughout the exercise including fire attack, EMS and vehicle extrication.

We also had a group of explorers that participated in a community service project with Colorado Civil Air Patrol where they painted the house of a person in need; the home was located in Castle Rock. Both of these items completed two goals that were set at the beginning of the year.

Our next big event is our annual academy. It will be held July 20th - 24th with a fundamentals day on the 25th. We have 7 explorer recruits that will be completing their first academy. Final planning for the academy is being completed and will be submitted to the Training Division and DC Croom for final approval.

Training at the PSTF continues to go very well; having all the resource options there has improved quality of delivery.

Life Safety Division:

Plan Reviews -

Plans submitted in to the Bureau range from Site Development Plans (SDP), Proposed Project Assessment (PPA), Zoning and construction plans. These come in from Development Services and then we also take fire sprinkler and fire alarm plans directly at the front desk. All together we reviewed 146 sets of plans for the month of June.

Along with plan reviews the Bureau is involved in inspecting all aspects of the building process that we have approved during the plan review phase. Some are pretty simple inspections, such as looking at the placement of fire sprinkler heads in the system to ensure they meet the standard, while others involve testing the entire system to ensure everything works the way they are designed to. In the month of June we completed 74 construction related inspections.

Hazardous Materials -


We maintain the Arapahoe-Douglas County Hazardous Materials database for the businesses within the fire protection district. While all businesses are required to report any hazardous materials that they are using, storing, and/or handling; if they don't meet the minimum threshold they are not required to submit storage site plans. With this we are required to not only evaluate the database, but also make a site visit to verify and ensure safe storage and handling practices. On average this really entails roughly three processes; verifying chemicals and SDS sheets, verifying quantities and appropriate storage areas, and physical inspection of the site. During the month of June we completed 11 total hazmat inspections.

Existing Business (occupancy) Inspections -

This is a large amount of our daily workload in the bureau. Not only do we conduct a primary inspection, we perform subsequent inspections of the occupancy to ensure compliance with the fire code. This is a process that over the life of the building the occupancy could be inspected several hundred times. During the month of June the bureau performed 214 inspections, consisting of primary, follow-up, and correction notice inspections. There was a total of 57 inspections that were completed, meaning that all violations had been addressed and were compliant or had no violations when the inspection was performed.

Public Education -

With having two new public educators in the bureau we are trying to implement new programs and polish the programs that were already in place. Some of the programs include Douglas County Youth Leadership, working with the Boy Scouts. During the month of June the public educators and line staff either scheduled, participated or facilitated a total of 17 events, allowing 486 public contacts resulting in 23.5 hours of work. Another portion of public education or assistance is the certified car seat installation program. Car seat technicians oversaw the installation of a total of 13 car seats for the public.
