

RESOLUTION NO. 2025-126

**A RESOLUTION APPROVING THE 2026-2030 FIVE-YEAR CAPITAL
IMPROVEMENT PROGRAM FOR THE TOWN OF CASTLE ROCK**

WHEREAS, the Town Manager, in accordance with Sections 9-5 and 9-8 of the Town Charter, has prepared the 2024-2028 Five-Year Capital Improvement Program (the “Program”) for the Town of Castle Rock (the “Town”), and

WHEREAS, the Program was considered at a public hearing before the Town Council at tonight’s meeting, as part of the 2026 Budget; and

WHEREAS, the Town Council finds and determines that the Program includes: (i) a clear general summary of its contents; (ii) a list of all capital improvements which are proposed to be undertaken during the five fiscal years next ensuing, in order of recommended priority, with appropriate supporting information as to the necessity for the improvement; (iii) cost estimates, method of financing and recommended schedules for each such improvement; and (iv) the estimated annual cost of operating and maintaining the facilities to be constructed or acquired, and the proposed method of financing such costs.

TOWN OF CASTLE ROCK AS FOLLOWS:**

Section 1. Approval. The 2026-2030 Five-Year Capital Improvement Program for the Town of Castle Rock is hereby approved in the form presented at tonight’s meeting.
