**A RESOLUTION APPROVING A SITE DEVELOPMENT PLAN FOR  
SINGLE-FAMILY RESIDENTIAL DEVELOPMENT WITHIN THE  
DAWSON TRAILS PLANNED DEVELOPMENT  
(Dawson Trails Filing No. 2, Tracts O and H)**

**WHEREAS**, ACM Dawson Trails VIII JV LLC, has requested approval of a site development plan (the “Site Development Plan”) for 256 single-family detached dwelling units and approximately 11 acres of private open space, including a neighborhood park, within the Dawson Trails Planned Development (the “Project”): and

**WHEREAS**, the Project is located on approximately 53.27 acres of property located south of the existing Territorial Road and west of the future Dawson Trails Boulevard, which property is within Planning Area D as shown on the Dawson Trails Planned Development Plan; and

**WHEREAS**, the uses associated with the Project are uses permitted by right in Planning Area D pursuant to the Dawson Trails Zoning Regulations; and

**WHEREAS**, according to Section 17.38.030 of the Castle Rock Municipal Code (“CRMC”), the Town Council has the requisite authority to approve the Site Development Plan, following a review and recommendation by the Planning Commission; and

**WHEREAS**, on May 8, 2025, a public hearing was held before the Planning Commission, which voted \_\_-\_\_ to recommend approval of the Site Development Plan to the Town Council; and

**WHEREAS**, based upon the evidence presented at a public hearing held at tonight’s meeting, the Town Council finds that the Site Development Plan is in substantial compliance with:

- (i) The goals and objectives of the Town of Castle Rock’s Vision 2030 and the 2030 Comprehensive Master Plan;
- (ii) The development standards set forth in the Dawson Trails Planned Development Plan and the Dawson Trails Zoning Regulations;
- (iii) The site development plan review and approval criteria set forth in CRMC Section 17.38.040; and
- (iv) The Town of Castle Rock Technical Criteria.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF CASTLE ROCK, COLORADO AS FOLLOWS:**

**Section 1. Approval.** The Site Development Plan for the Project is hereby approved in the form presented at tonight’s meeting.
