## **RESOLUTION NO. 2015-52**

## A RESOLUTION RATIFYING ORDINANCE NO. 2015-09 UPON STATUTORY RECONSIDERATION PURSUANT TO SECTION 31-11-105, C.R.S., AND DIRECTING ADMINISTRATIVE ACTION NECESSARY TO ENABLE THE REFERRAL OF THE REFERENDUM ON THE ORDINANCE TO A SPECIAL MUNICIPAL ELECTION

**WHEREAS**, the Town Council adopted Ordinance No. 2015-09 (Ordinance) which approved an amendment to the Town's Zone District Map by approving the Promenade at Castle Rock Planned Development Plan, an amendment to a portion of the Castle Pines Commercial PD (2000) Amendment; approved the Promenade at Castle Rock Planned Development Zoning Regulations and the Promenade at Castle Rock Development Agreement; and vested the subject property as a site specific development plan, and

**WHEREAS**, on April 13, 2015, a petition protesting the effect of the Ordinance (Petition) was filed with the Town Clerk in accordance with Title 31, Article 11, C.R.S., and Section 15-2 of the Town of Castle Rock Home Rule Charter, and

**WHEREAS**, on May 26, 2015 the Town Clerk made a final determination that the Petition was legally valid and sufficient and pursuant to statutory requirements referred the Ordinance to the Town Council for reconsideration, and

**WHEREAS,** the Castle Rock Town Council on June 2, 2015 reconsidered the Ordinance as mandated by §31-11-105(3), C.R.S. As part of the reconsideration, the Town Council has reviewed the March 3, 2015 Agenda Memorandum summary that was presented with the Ordinance on second and final reading.

## NOW, THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF CASTLE ROCK AS FOLLOWS:

- **Section 1. Ratification**. Ordinance No. 2015-09 is ratified in its entirety.
- **Section 2.** <u>Further Action</u>. The Town Manager is directed to develop and present a proposed ordinance for consideration on first reading on June 9, 2015, which ordinance will refer the referendum on Ordinance 2015-09 to a special municipal election in conformance with applicable statutory and Charter requirements.
