Hello Sara,

The Castle View Bands program begins the year with a two-week marching band summer camp, which is required for students to attend. This is a two-week all-day training program in late July where students prepare for the marching band season. Several hours of camp are also dedicated to preparing student marchers for the Douglas County Parade. DCSD funding covers basic program needs such as musical instruments, music licensing, salary/wage for instructors, and transportation for long distance events. The CV Band Booster Club exists to raise funds that help cover the additional expenses of running the program, which consists of providing food and water for camp and competitions, CV Bands branded apparel for students, and special events throughout the year that promote morale and bonding among the students.

The Town of Castle Rock grant funding will be allocated toward marching band summer camp expenses, including water, gatorade, and snacks provided during summer camp and CV Bands branded shirts for new marchers. The CV Band Booster Club also hosts a pool party at the MAC at the close of the summer camp training and at no cost to the students. Grant funds will be used for food and beverages, MAC pool passes, and pavilion rental fees.
