#### **COUNCIL COMMENTS**

Mayor Gray thanked everyone for their condolences in the passing of his mom.

Councilmember Hollingshead acknowledged that season passes to the summer Parks & Recreation concert series are available tomorrow.

Councilmember Cavey spoke in opposition to State Bill 23-213 and acknowledged the recent tragedy in Nashville.

Councilmember LaFleur noted that May is Historic Preservation month and highlighted the Blue Jeans Ball on May 13th, honoring and supporting mental health services for front line responders.

Coucilmember Brooks encouraged everyone to research Senate Bill 23-213. He

acknowledged the attendance at the recent open house for the Pavement Maintenance Program and also noted he received many compliments from other attendees at the National League of Cities conference in regard to the good things going on in Castle Rock.

## ID 2023-039 Update: Town Website Redesign

Kristin Read, Assistant Town Manager introduced Melissa Hoelting, Communications Manager, who presented an overview of the redesign of the Town's website which was last redesigned in 2015. The update focused on the responsiveness of the website with mobile devices as well as addressing compliance with a new state law regarding website accessibility. The redesigned website will go live on April 14.

### ID 2023-040 Update: Calendar Reminders

Dave Corliss, Town Manager, noted the State Demographer presentation on April 6 as well as the Boards & Commission interviews scheduled for May 9th. Community events highlighted included the State of the Town Event on August 17, and tentative Open House dates for Council Districts, many of which are scheduled at the newly acquired Cantril School facility. ## RES 2023-047 Resolution of the Town of Castle Rock, Colorado in Opposition to Statewide Land Use and Zoning Preemptions in Senate Bill 23-213

Town Manager, David Corliss, reviewed the impact of Senate Bill 23-213 legislation upon Castle Rock. He explained that the bill is an attempt to remove the single family only zoning district in urban Colorado, including Castle Rock. The bill also removes the authority of the municipality to address public health and safety issues associated with the proposed removal of single family zoning districts. Most significantly, the bill eliminates municipal home rule authority and local control. The end result, per Corliss, would be that the municipality would be left to deal with all the issues created by the bill to include parking, incompatibility, occupancy standards and water, wastewater and stormwater burdens. The Town has drafted a letter of opposition to the proposed bill

roadways for an extended period of time due to weather conditions. The amendment allows for the Town Manager preemptive authority to deploy treatment ahead of a similar weather event should it occur in the future.
