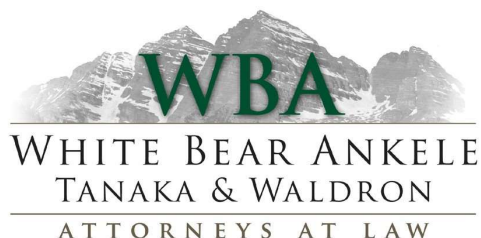

Per our previous conversation, please find enclosed a submittal package concerning the proposed issuance of bonds by the Crystal Valley Metropolitan District No. 2 Subdistrict (the “**Subdistrict**”) for the Town Council’s consideration. This submittal is made pursuant to the requirements of the Amended and Consolidated Service Plan, which was approved by the Town Council on November 21, 2001, as further amended on May 6, 2014, by the First Amendment to the Amended Consolidated Service Plan and thereafter by the Second Amendment on July 21, 2020 (collectively, the “**Service Plan**”) and the Town of Castle Rock Code requirements set forth at Section 11.02.110. We understand that the transaction is currently scheduled for consideration by the Town Council at its regular meeting scheduled for June 7, 2022 and we will plan on having representatives of the Subdistrict in attendance.

In addition to the attached submittal for the 2022 Bonds, we have also previously submitted the proposed Construction Escrow Agreement and the Master IGA with the Town for consideration.
