# January 2018 Monthly Report

# **Department News:**

The department held its annual awards dinner in late January; a number of members were recognized with certificates of commendation, clinical save commendations, unit citations, years of service, and the Chief's Choice Award. #### **Customer Service:**

**Measurable Outcomes** - Rating of 4 or better on customer survey cards 100% of the time **January 2018...100**%

Of the 25 Customer Survey cards rating service in January, 23 were of the highest overall rating of 5 and 2 had an overall rating of 4. #### **Call Statistics:**


For the month of January we responded to 501 calls for service. Last year at this time we responded to 458 calls. This places our year to date calls at 501 which is 43 over last year, an annual increase in call volume of 9.4%.

Of the 501 calls for service in January, 303 of the calls were for EMS. We had a total of 281 patient contacts and transported 222 patients. This time last year we had 208 transports.

#### Fire Calls:


During the month of January we ran 3 fire calls compared to 4 last year. We had 28 alarm calls compared to 40 last year at this time. Alarm calls are closely related to new commercial construction, where alarms are generated as new systems come on line.

#### **Emergency Medical Service Calls:**

The most common EMS calls in January were for leg pain with 21 patients, the second most common was for abrasions/lacerations with 20 patients.




#### **Measurable Outcomes:**

For the month of January,161 patients were transported to Castle Rock Adventist, which is 72.5% of all patients transported, 54 patients were transported to Sky Ridge, which is 24.3% of all patients transported.



#### **Significant Incidents:**


**C Shift:** On January 5<sup>th</sup> Engines 151, 153, and 154, Medics 151, 153, and 154, Quint 155, Battalion 151, Division 151, and Chiefs 151 and 152, along with Franktown and South Metro Fire Units responded to 7539 Kimberly Dr. on a structure fire. There were no complications or further incidents during this call. The investigation was completed by Investigator Young.

On January 24<sup>th</sup> Engine and Medic 153 and Battalion 151 responded to an address in Founders on a medical assist that was a cardiac arrest. The patient regained pulses after resuscitation efforts on scene and was transported to the hospital. The patient continued to improve and was discharged from the hospital on 01/27/18 without any deficits.

#### **Key Operational News:**

On January 5<sup>th</sup>, department members participated in the funeral service for Douglas County Deputy Zack Parrish, who was killed in the line of duty on December 31<sup>st</sup>. The department's Peer Support Team continues to be available to both DCSO and CRPD if needed or requested. RIP Deputy Parrish.

Members have continued teaching the Stop the Bleed (STB) program to STB kit recipients. The training is relatively easy, discusses how to apply the items found in the STB kits, and can be taught by any of our members who attended the class. We have begun deploying these kits throughout the community and will be working specifically with the Douglas County School District on which schools to deploy these kits.

Division Chief McCarthy and Lieutenant Richardson are developing a plan in support of Peer Assessment Recommendation #10, "It is recommended that the agency develop a program to enhance the wildland training requirements for officers and chief officers" detailed in Self-Assessment section 5K.4. This will likely take several years to ensure all officers have an opportunity to attend the classes while on-duty.
