

**RESOLUTION NO. 2024-079**

**A RESOLUTION DIRECTING THAT THE NOVEMBER 5, 2024,  
REGULAR MUNICIPAL ELECTION OF THE TOWN OF CASTLE  
ROCK BE CONDUCTED BY DOUGLAS COUNTY AS A  
COORDINATED ELECTION**

**WHEREAS**, pursuant to Section 4-2 of the Town of Castle Rock (the “Town”) Home Rule Charter, regular municipal elections are to be held each even-numbered year on the first Tuesday following the first Monday of November, and

**WHEREAS**, there will be a regular municipal election of Town Councilmembers for Districts 1, 2, 4 and 6 on Tuesday, November 5, 2024 (the “2024 Regular Municipal Election”); and

**WHEREAS**, Section 2.01.300 of the Town Municipal Code prescribes that the Town Council may determine any regular election shall be conducted by Douglas County as a coordinated election, and

**WHEREAS**, Town Council finds and determines that it is necessary and advisable for the 2024 Regular Municipal Election to be conducted by Douglas County on behalf of the Town under the Uniform Election Code of 1992, as authorized under Section 2.01.300 of the Town Municipal Code; and

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF CASTLE ROCK AS FOLLOWS:**

**Section 1. Conduct of the Regular Election.** The 2024 Regular Municipal Election shall be governed by and conducted in conformance with the Uniform Election Code of 1992, as a coordinated election, and pursuant to an Intergovernmental Agreement between the Town and the Douglas County Clerk and Recorder regarding the conduct and administration of said election to be approved at a later date (the “2024 Election IGA”).

**Section 2. Authorization.** Officers and employees of the Town, including, but not limited to, the Town Clerk in her capacity as the designated election official of the Town, are authorized to take all actions necessary to effectuate the provisions of this Resolution and conduct the 2024 Regular Municipal Election in accordance with the Uniform Election Code of 1992 and the 2024 Election IGA.
