METZLER FAMILY OPEN SPACE

In June 2021, Town Council approved a resolution accepting the donation of property from the estate of Robert F. Metzler northwest of the Crowfoot Valley Road and Founders Parkway intersection. This 60-acre property has since been named the Metzler Family Open Space and features a historic homestead, silo and outbuildings along with ranchland dating back to Douglas County's homesteading.

The donation included conditions to meet Bob's wishes:

- Construction of soft-surface trails (completed 2022)
 - Restoration of silo (completed 2022)
 - Installation of signage (nearing completion)
 - Parking

PROJECT BACKGROUND

- Town Council approved a resolution accepting the donation of real property from the estate of Robert F. Metzler and the conditions of the donation deed on June 1, 2021.
- A press release announcing the donation and planned parking and trails was issued on June 25, 2021 with updates to Facebook, Twitter and the Town's website (CRgov.com/MetzlerOpenSpace).
- Information regarding the trailhead parking lot project was distributed on the area's Nextdoor.com on February 2, 2022 and staff met with the HOA to review area improvements.
- Weather dependent, substantial completion is scheduled for December 23, 2022 with final completion in February 2023.



BUDGET

The Town solicited construction bids via Rocky Mountain E-Purchasing System to construct access and trailhead parking at Metzler Family Open Space. Two bids were received:
