# 2021 RATES AND FEES

## KEY ASSUMPTIONS AND INPUTS

- Make Interfund Loan from Wastewater to Water
- Smooth required rate increases
- Continue hybrid renewable water projects
- Utilize Town growth forecast
  - *Actual growth has exceeded projected growth by an average of over 10% over last five years*
- Use revised build-out estimates for water supply
- Ensure growth helps pay for growth
- Change timing and amounts of investments for capital projects
  - *Based on market and business conditions and actual growth*
- Maintain current levels of service
- Escalate operational costs at 1.55% and capital costs at 2.85% each year beyond 2021

# 2021 RATES AND FEES

## KEY ASSUMPTIONS AND INPUTS-CONTINUED

- Add 3 additional full time equivalents
- Assume conservation goals will be met
  - *This is 18% reduction by 2050*
- Fund Administrative building in 2021
- Estimate investment income at 0.60%
- Maintain minimum reserves
- Assume non-residential water budget changes have financial consequences in 2021
- Eliminate the reduced water resources fee for 0.67 SFE homes going forward
- Continue to not include advanced metering infrastructure in long-term CIP

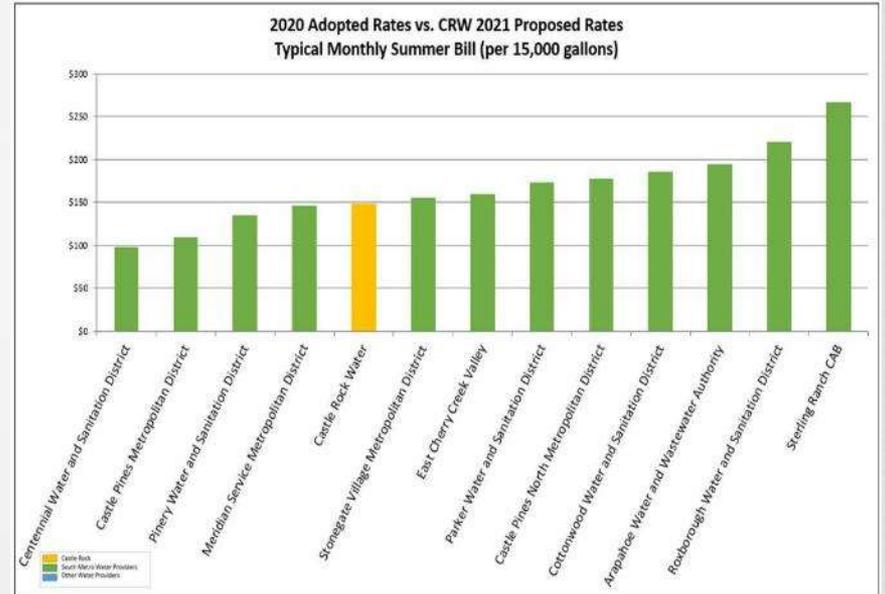
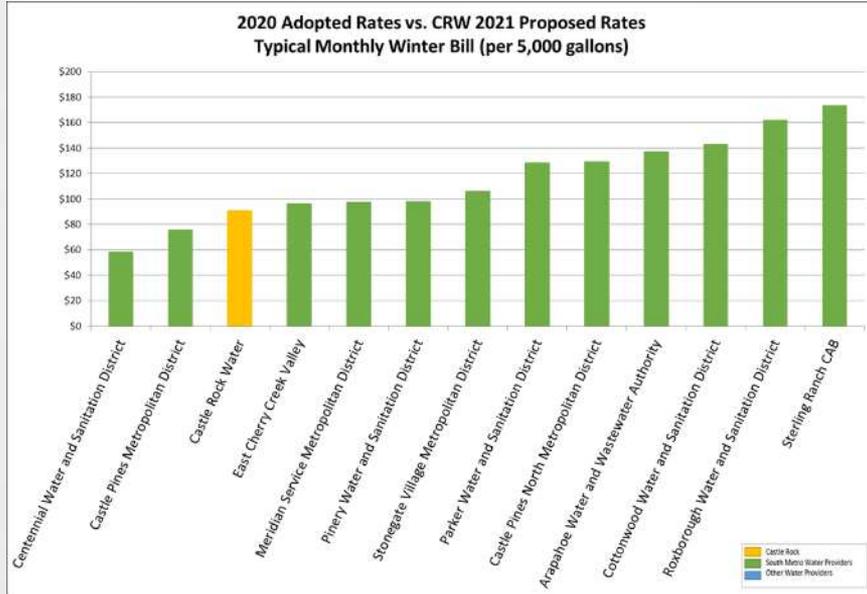

Stormwater, Cherry Creek	\$868	\$1,388	\$520	59.9%
<b>TOTAL Cherry Creek</b>	<b>\$26,178</b>	<b>\$34,460</b>	<b>\$8,462</b>	<b>32.3%</b>

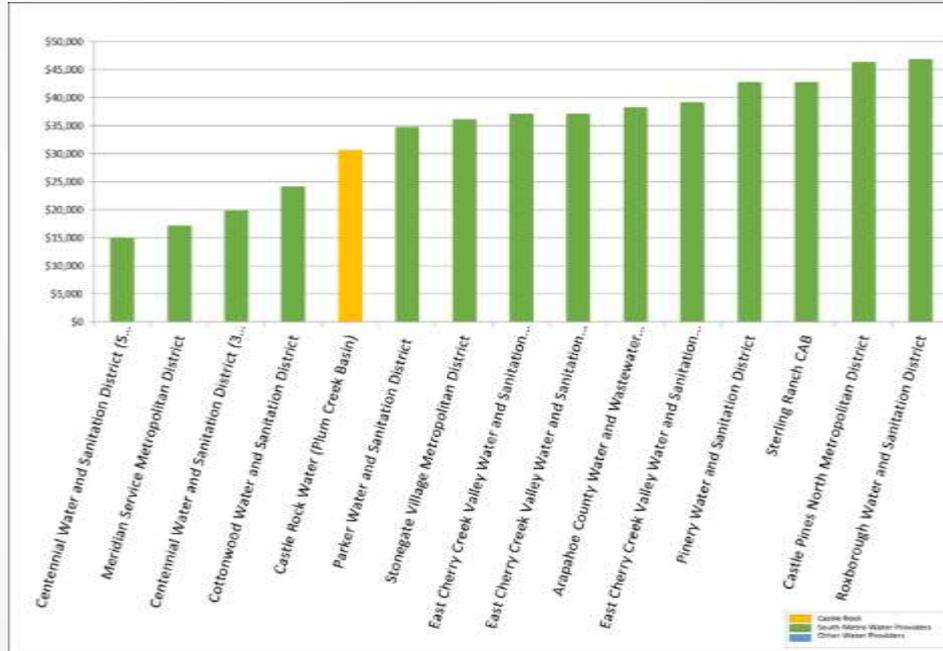

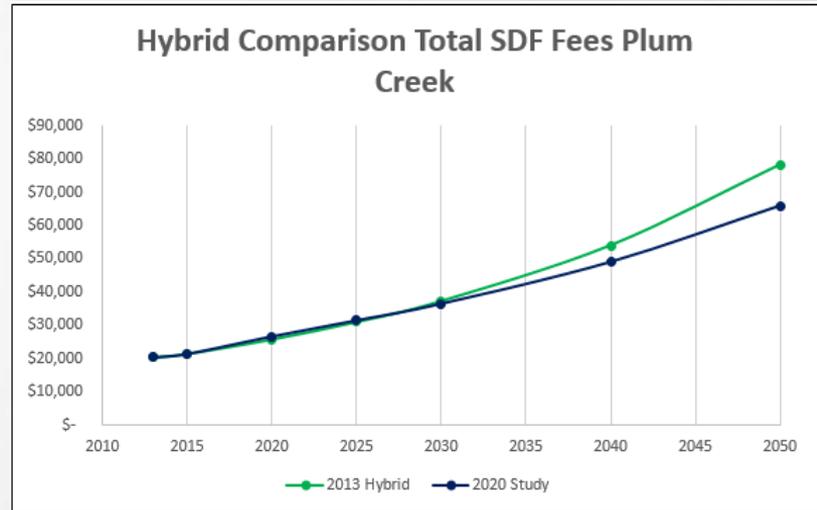
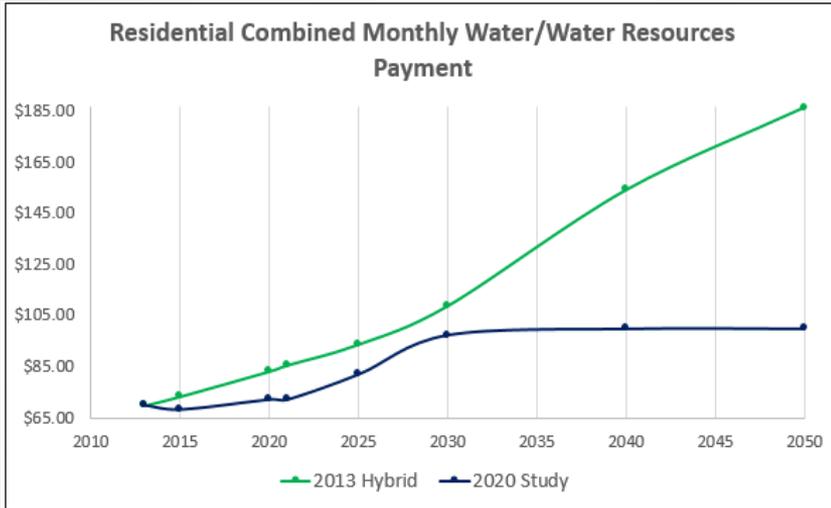
2021 PROPOSED SDFS COMPARED TO SURROUNDING COMMUNITIES 2020 SDFS



\*The Parker Water SDF may include an additional \$5K Water Resource's Toll, for a ¾" meter. Castle Rock SDF is calculated using the Plum Creek Basin stormwater DIF.

# 2021 RATES AND FEES

## KEY CONCLUSIONS

- No change in water, water resources, stormwater, wastewater rates
- No change in annual costs for a typical ¾" residential customer
- 4.9% increase to system development fees for Plum Creek and Cherry Creek
- Both residential and non-residential meter set fees average increase between 3-5%
  - *Based on actual cost of meters from vendor, no change to our cost of service*
- Minor changes to special charges
- Meeting Financial Management Plan goals
- Inter-fund loan supported by modeling results
