# QUALITY OF LIFE


#### CORE SERVICE LEVELS ESTABLISHED IN PARKS AND RECREATION MASTER PLAN

- Build parks within safe walking distance of residents (half-mile service radius)
- 8 developed park acres per 1,000 residents
- Assess and plan renovations at existing facilities to sustain current levels of service
- 2015 Philip S. Miller Park
  2017 Festival Park
  2019 Deputy Zack S. Parrish III Memorial Park
  2022 Cobblestone Ranch Park
  2023 Butterfield Crossing Park
  2024 Mitchell Gulch Park
  2024 Plum Creek North Park



### **PLUM CREEK NORTH PARK**

This project was identified as a priority in the department's 2019-2024 Capital Improvement Plan and will construct a new park at 2225 Emerald Drive.



## **PROJECT BACKGROUND**

- Several Executive Sessions held throughout 2019 to discuss potential acquisition
- May 2019 Town Council provided opportunity for public input on land acquisition
- Independent appraisal performed by Kilty and Company
- Purchase approved and completed late 2019
- Amenities deemed to be beyond repair and removed to ensure public safety and prepare for future park development



#### **PARK MASTER PLAN**

Landscape architect DHM Design Corporation (DHM) engaged residents and staff to assess needs and desires and obtain public input to create the park's design.



### BUDGET

The Town issued an Invitation for Bids (IFB) via the Rocky Mountain E-Purchasing System for the Plum Creek North Park project and two responses were received:

General Contractor	Bid Amount
Colorado Designscapes, Inc.	\$3,682,350.00
Native Sun Construction, Inc.	\$5,274,773.94

In addition to the base bid, project costs will include an allowance for signage and an allowance for flared-end section - both of which are included in the Colorado Designscapes contract - for a total contract authorization amount of \$3,737,350.

To reduce project costs, staff will purchase playground equipment directly and contract its installation. Town-managed contingency, additional Town-managed allowance and permit and system development fees will result in a total project cost of \$4,646.560.88.

### BUDGET

\$3.5 million was approved for this project in the 2023 budget. An additional \$1.1 million allocation will require Town Council approval through a budget amendment, which is scheduled for June 20, 2023. The Plum Creek North Park Project will be expensed to the Parks and Recreation Capital Fund account number 130-5275-452.75-21.
