ORDINANCE NO. 2015-57

AN ORDINANCE AMENDING THE TOWN OF CASTLE ROCK ZONING DISTRICT MAP BY REZONING A 59.931 ACRE PARCEL DENOMINATED AS THE LOWER EAST PLUM CREEK PARK AND OPEN SPACE ANNEXATION TO PARKS, RECREATION, AND OPEN SPACE (POS-1 – ACTIVE USES)

WHEREAS, the Town Council approved the Lower East Plum Creek Park and Open Space Annexation by Ordinance No. 2015-56 (the "Annexed Property"),

WHEREAS, §31-12-115 C.R.S. requires the zoning of the Annexed Property within ninety days of annexation; and

WHEREAS, the proposed change in zoning classification from Douglas County Planned Development/Agriculture One to Parks, Recreation, and Open Space (POS-1 – Active Uses) meets the goals and policies of the Town's Vision 2020 and Comprehensive Master Plan.

NOW, THEREFORE, IT IS ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF CASTLE ROCK, COLORADO:

- **Section 1. Zoning Classification / Zone District Map Amendment.** The Annexed Property, more particularly described in the attached *Exhibit 1*, shall be designated with the zoning classification POS-1 –Active Uses. The Town's Zone District map, as it pertains to the Annexed Property, is amended to conform to the zoning classification POS-1-Active Uses.
- **Section 2.** <u>Severability.</u> If any clause, sentence, paragraph, or part of this ordinance or the application thereof to any person or circumstances shall for any reason be adjudged by a court of competent jurisdiction invalid, such judgment shall not affect the remaining provisions of this ordinance.
- **Section 3.** <u>Safety Clause.</u> The Town Council finds and declares that this ordinance is promulgated and adopted for the public health, safety and welfare and this ordinance bears a rational relation to the legislative object sought to be obtained.
