Comment*

I am in favor of SRO's in our high schools, middle schools, and elementary schools. I am somewhat skeptical of the cost sharing going forward. In the past DCSD funded the program entirely, as the Officers were essentially dedicated to their campuses full time rather than providing services to the Town as a whole. The amount of Officers and Supervisors is increasing, not just here but in the other jurisdictions within Douglas County, and they're now seeking 50% of the funding to come from the Town. So in essence the school district will receive more resources, but pay less per resource going forward. Our school district has shown time and time again they have great difficulty in managing their finances effectively so I believe this opens the town up to subsidizing their bad financial management. I would hope this agreement is well thought out and detailed to prevent it being abused, or to become a starting point for future negotiations to increasingly try to shift the cost burden to the Town by the school district. Personally I think if this service is strictly benefitting the schools, they should budget for it without requiring additional funding from Castle Rock, Parker, Lone Tree and the County.
