Virtual annual audits

April 12 - 30, auditors from BKD CPAs & Advisors performed a Field Audit of the Town's 2020 financial reports.

In February, BKD performed the Single Audit of CARES Act funds that the Town received in 2020, due to the COVID-19 pandemic. This audit occurs organization-wide in an entity that expends \$750,000 or more of federal assistance received for its operations.

The audits took place virtually in regular meetings with the Accounting Team and included Town departments as needed.

BKD plans to present results of the annual financial statement audit to the Audit Committee in May.



Preliminary Townwide expenditures by category April 30, 2021














Revenue



As sales tax returns are due 20 days after the end of the month, this report shows the prior month's revenue.

Communicating results

Sales tax collections for March were up 15.6 percent from the previous year's month, or up \$690,413 compared to March 2020. Year-to-date (YTD) collections are up 13.5 percent compared to the same time frame in 2020. As March wraps up, the outlook for sales tax remains cautiously optimistic. Staff is attributing the high numbers of the first quarter to the spending of stimulus checks with additional pent-up spending. Staff will continue to monitor this very important revenue stream for the Town and inform as needed.
