



Dear Mr. Linn, Ms. Fienen and Mr. Brooks:

This letter is in response to the form petition to recall the above-referenced officer of the Town of Castle Rock, which was submitted on Monday March 21, 2016. Pursuant to C.R.S. § 31-4-502(1)(c), I have reviewed the form of the petition to determine whether it meets the requirements of C.R.S. § 31-4-502.

You are hereby advised the petition form is APPROVED and authorized for circulation.

Section 15-3 of the Town Charter requires a recall petition be signed by registered electors of the district from which the Councilmember sought to be recalled was elected, in an amount that is twenty-five percent (25%) of the entire vote cast at the last preceding election for all candidates for the office which the Councilmember occupies. There were 1071 votes cast for Councilmember for District 5 at the last preceding election at which a Councilmember from District 5 was elected. Therefore, this petition will require at least 268 valid signatures for it to be deemed sufficient pursuant to the Town's Charter.

Please be aware of the following with regard to petition circulation: Section 15-3(c) of the Town Charter provides that no signature on a recall petition shall be valid if signed on a date more than thirty days prior to the date the signed petition is filed with the Clerk; pursuant to C.R.S. § 31-4-502(1)(c), any petition signatures dated prior to March 11, 2016 shall not be valid; and in accordance with C.R.S. § 31-4-503(2)(d), any disassembly of the petition that has the effect of separating the affidavits from the signatures shall render the petition invalid and of no force and effect. Note the petition must be stapled prior to circulation, and it must be circulated in the approved form.

Please remember, with the approval of this revised petition, the approval granted on March 11, 2016 will no longer be valid and only the revised petition form may be circulated.

Finally, my review is only of the petition form and does not extend to the substance of the petition, nor can this office provide you with legal advice. By approving the petition form, I make no findings as to the truth or accuracy of any statements made therein.

Dear Ms. Misare:

I currently represent Ms. Renee Valentine with respect to her protest of the Statement of Sufficiency for the recall petition involving her office. With this letter, please accept the withdrawal of her protest of the Statement of Sufficiency.

Although withdrawing the protest, we will nonetheless be forwarding evidence of election fraud to the District Attorney. Our analysis shows multiple instances of apparently forged signatures. Many of these signatures were already thrown out based on other irregularities. But the possibility of fraud is real, and it warrants a criminal investigation.

In light of these problems, it's unfortunate that the petition signatures were not compared to existing signatures on the voter rolls. More worrisome, the Douglas County Clerk and Recorder's office informally compared several signatures and found a handful that did not match. Some of the names were on petitions that had already been thrown out, so rather than go forward with the protest, this information will also be forwarded to the District Attorney.
