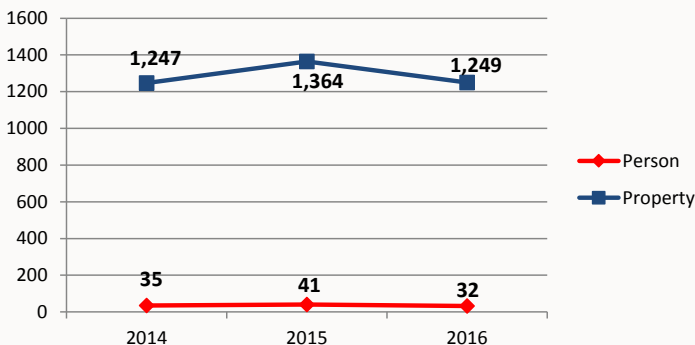

FRAUD'S **RED** FLAGS

Scams are ever-present nowadays, whether it's online, on the phone, or in your mail. Seniors tend to be the most prone to these scams, but all citizens should remain diligent, regardless of age, to avoid becoming a victim. Here are some warning signs that the deal you heard about is indeed "too good to be true" and is actually a scam:

- Be wary of anyone promising guarantees that an investment will perform a certain way. All investments carry a certain degree of risk, and their performance is never a guarantee.
- Many scams involve unlicensed people selling unregistered items, such as stocks, bonds, notes, hedge funds, oil or gas deals, and other fictitious investments.
- Avoid anyone crediting a highly complex investing technique for an unusual amount of success. Any legitimate professional should be able to clearly explain what it is they are doing.
- Make sure you fully understand any investment you are considering – what their risks are, exactly how the investment makes money, etc.
- If someone tries to sell you an investment with no documentation, he or she may be selling unregistered securities or items.
- If the person becomes aggressive, angry, pushy, or begins making threats on the phone, hang up immediately, write down the phone number, and call law enforcement.
- It is worthy to note that not all scammers will become aggressive or pushy, but still be wary about giving out personal information.



If you believe you have been the victim of a scam, be sure to report the incident to the Castle Rock Police Department! Then, contact your bank immediately to ensure they are aware of the situation so that no further financial damage occurs on your account.



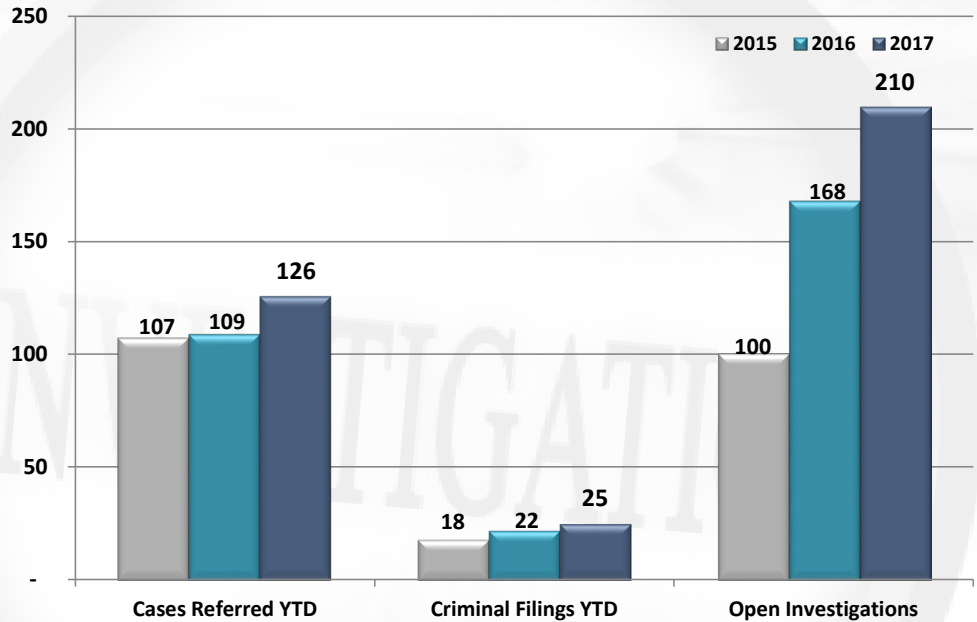
DETECTIVE UNIT

On January 31, Richard Lockett plead guilty to 1st Degree Murder and was immediately sentenced to life without the possibility of parole in Douglas County District Court. Lockett was arrested on murder charges by the Castle Rock Police Department on July 18, 2015.

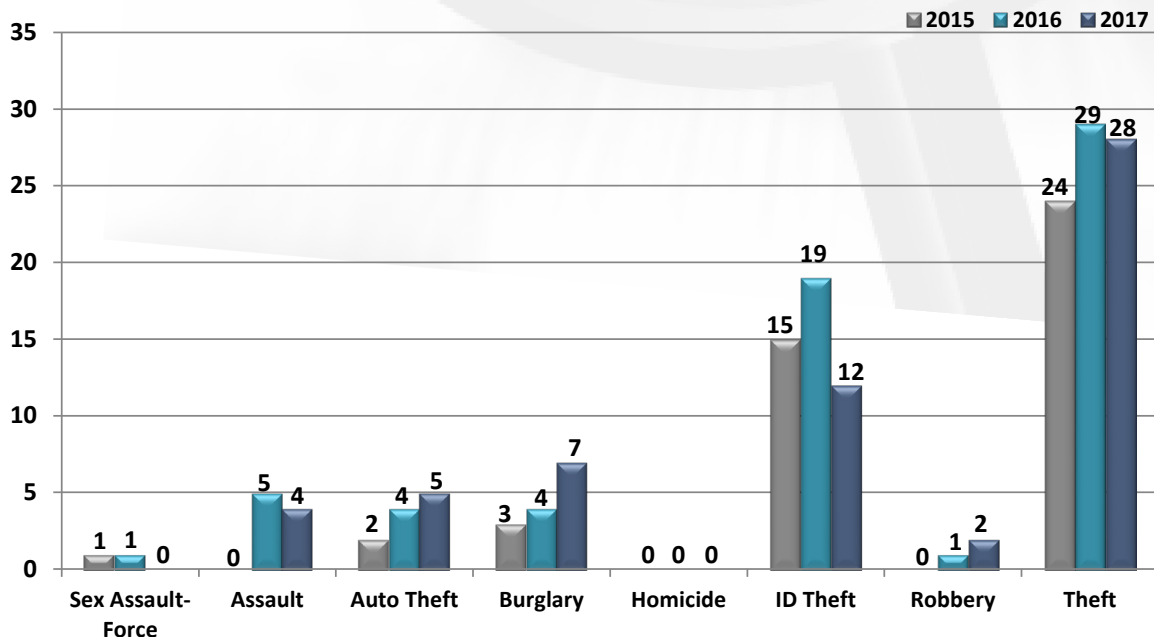
Castle Rock Police Detectives assumed the primary investigative role for both the Lincoln County and Castle Rock cases. Detectives Finley and Williams were assigned as co-Lead Detectives for this investigation. Detectives were divided into several teams. They conducted numerous interviews and executed multiple search warrants in Lincoln County, El Paso County and Douglas County (Castle Rock). The use of extensive forensic cellular communication analysis was significant during this case.

After the plea and sentencing hearing, the Senior District Attorney gave extremely high praise to the Castle Rock Police Department for their efforts. He mentioned that he was proud to work with Castle Rock Police and the community should be very proud of this agency. Of particular note was the Public Defender's comments. In open court, the Public Defender praised the work and professionalism of the Castle Rock Police Detectives participating in this investigation.

JANUARY (2015-2017)



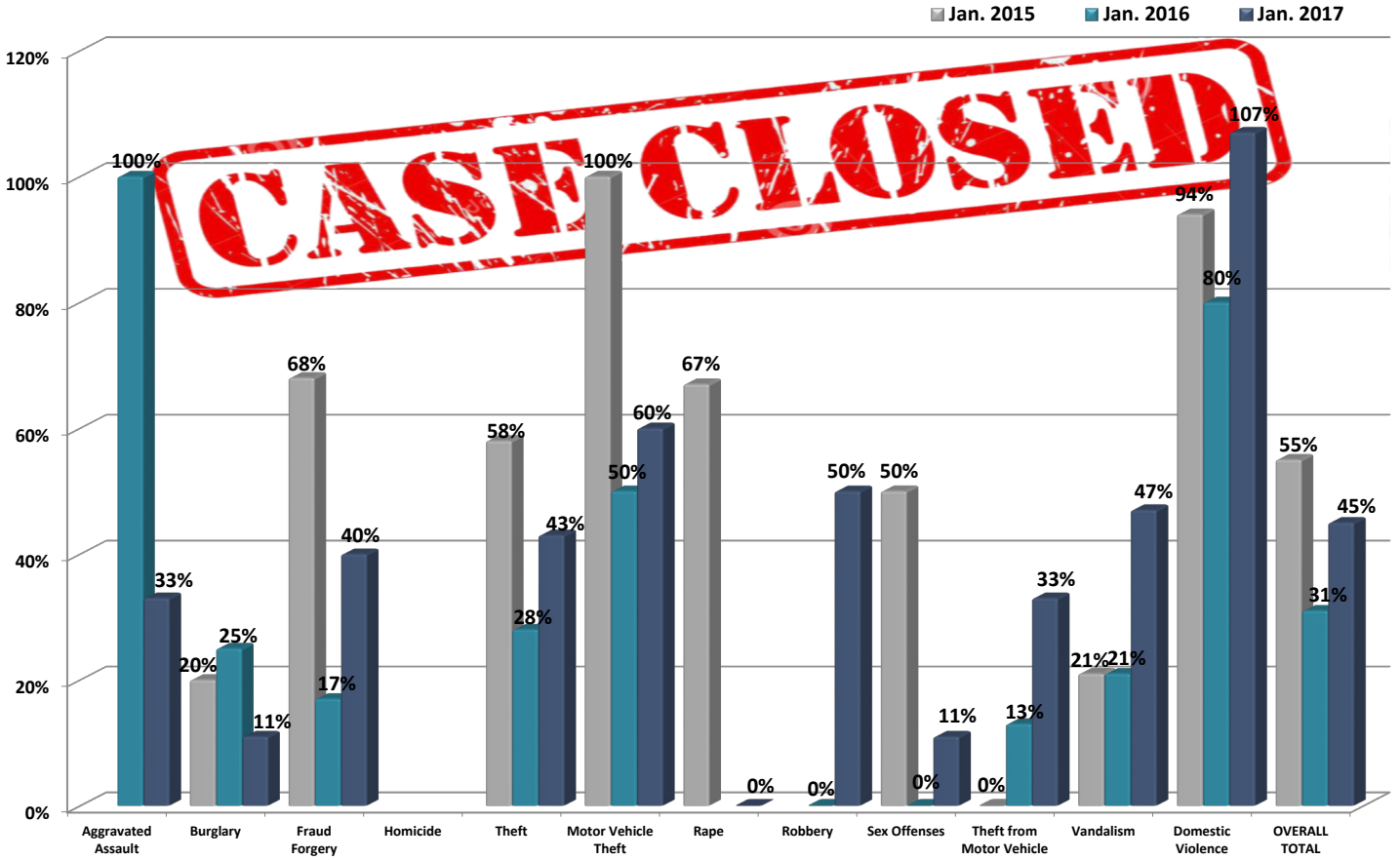
3-YEAR CRIME TREND COMPARISON

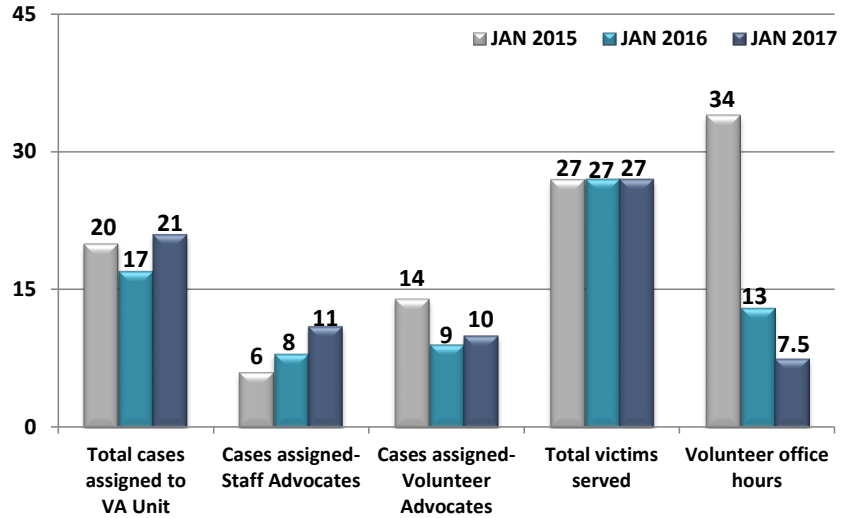

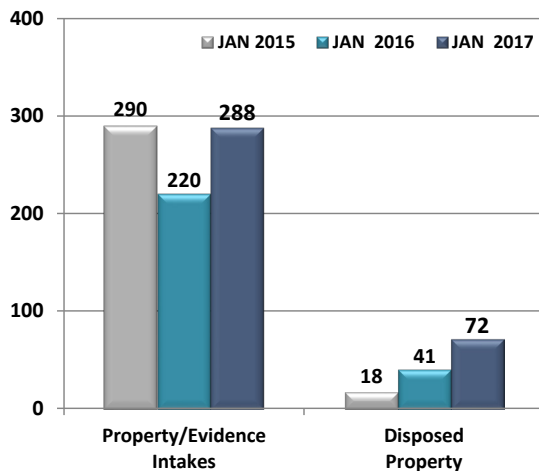

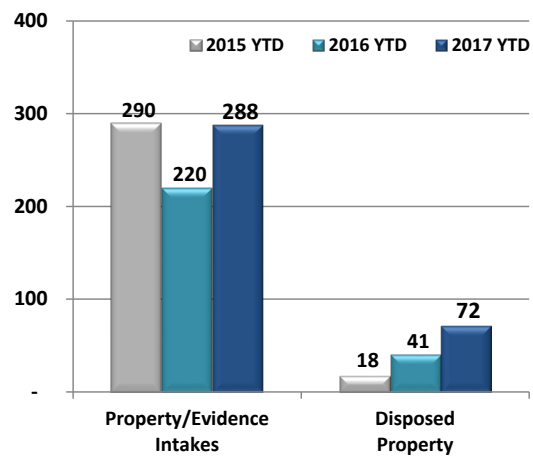

Demonstrations - Titan and Ronin participated in demonstrations including providing orientation for the new officer hires.



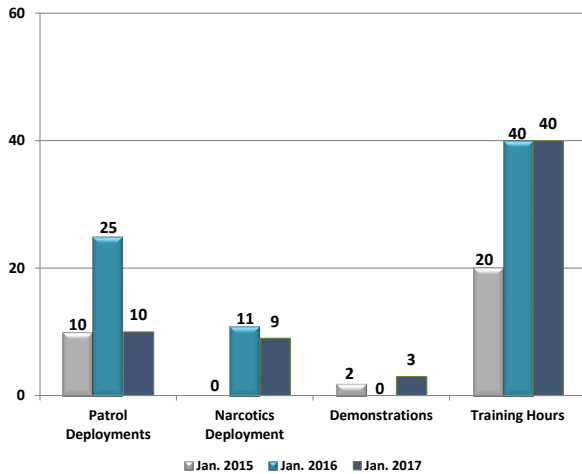

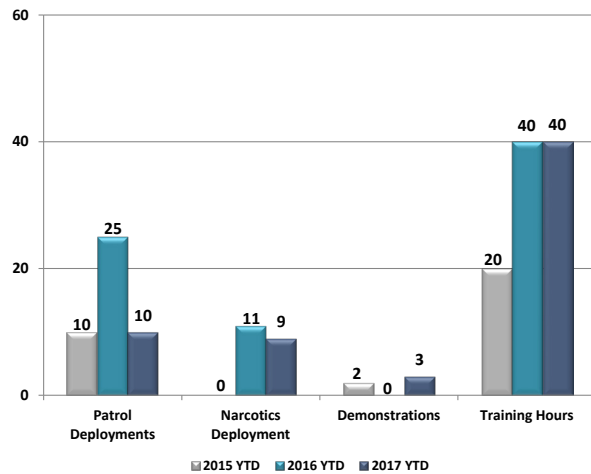
Castle Rock K9 was invited by the students of Rock Canyon High School to be interviewed for an upcoming effort by the school to help retired police dogs.



K-9 ACTIVITY: MONTHLY COMPARISON JANUARY (2015-2017)



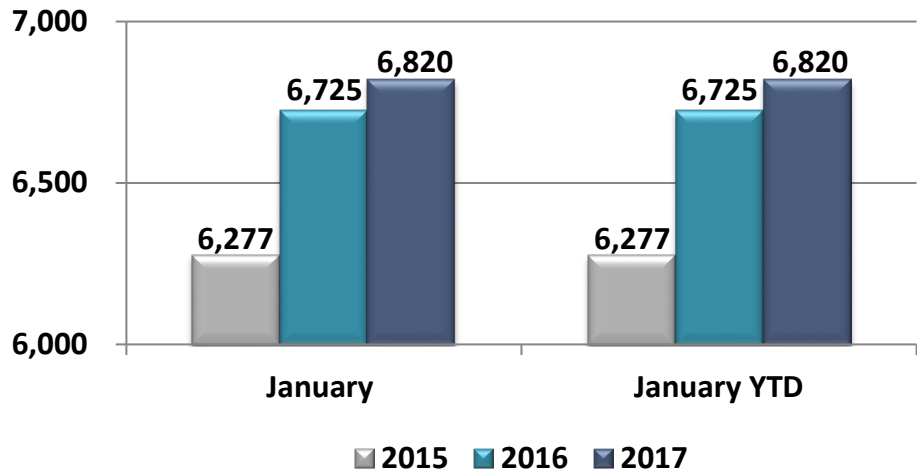
YEAR-TO-DATE COMPARISON JANUARY (2015-2017)

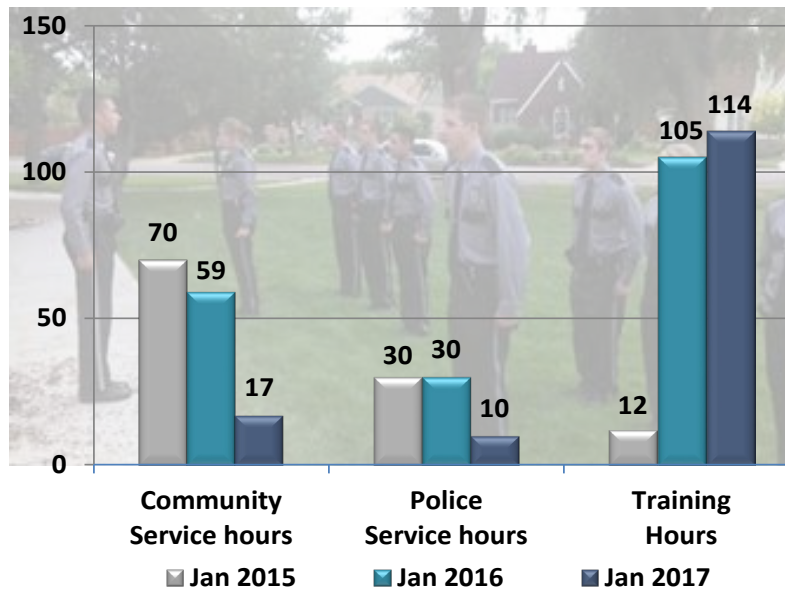

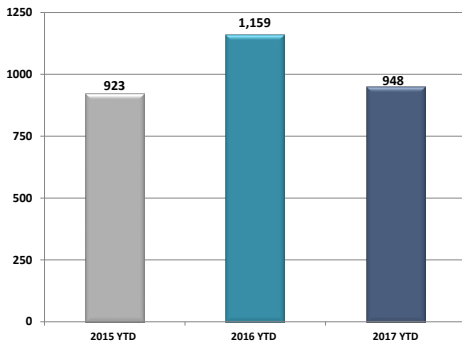

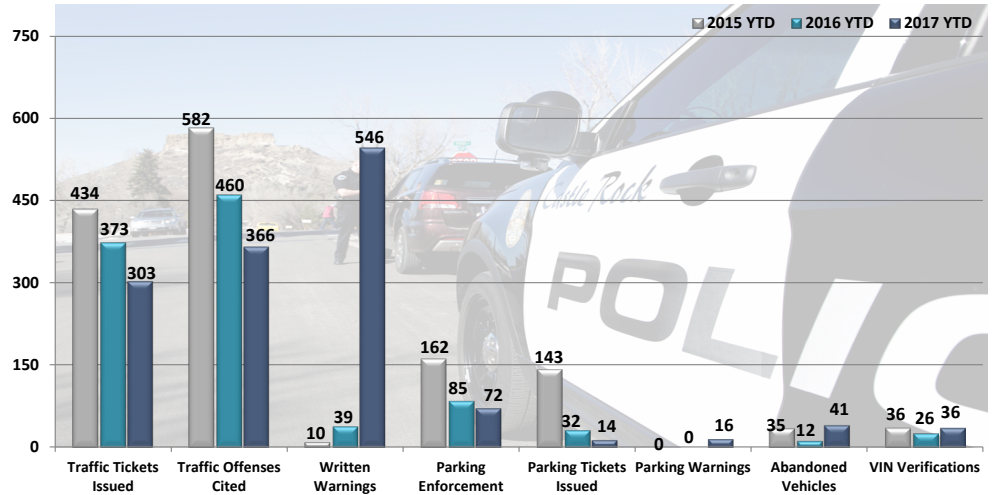

On January 24, the Castle Rock Police Department participated in "Operation Move Over." Officers from the Special Operations and Patrol divisions partnered with agencies in Douglas, Arapahoe and Denver counties to conduct High Visibility Enforcement on Interstate 25.

After the deaths of two CSP troopers in just over a year on the highway, the agencies targeted vehicles failing to move over for stationary emergency vehicles. CRPD officers stopped 45 motorists for traffic law violations. They provided education on the "move over" law and provided 35 warnings. Officers did issue ten summonses during the deployment as well. During the day, a total of 477 traffic stops were made by the partnering agencies; thus, increasing the awareness and enforcement on the "move over" law.

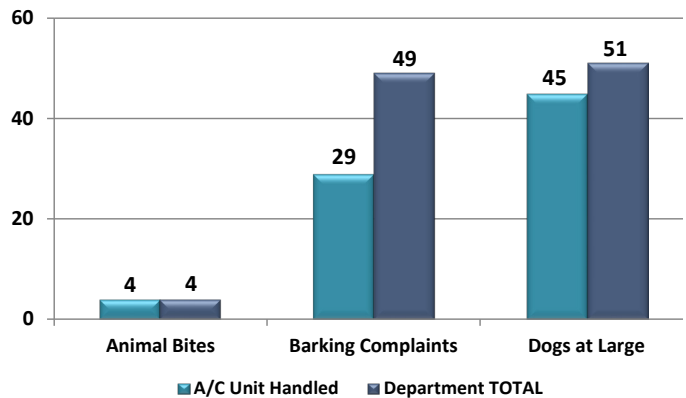

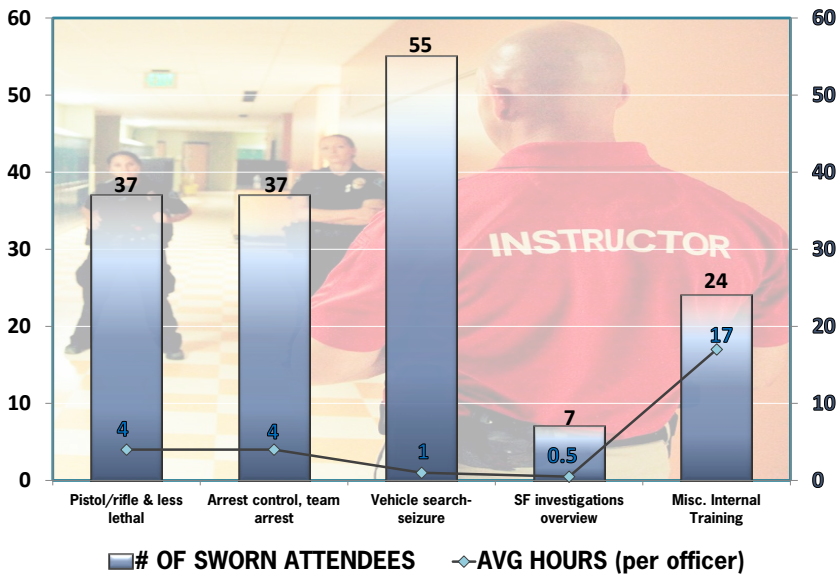

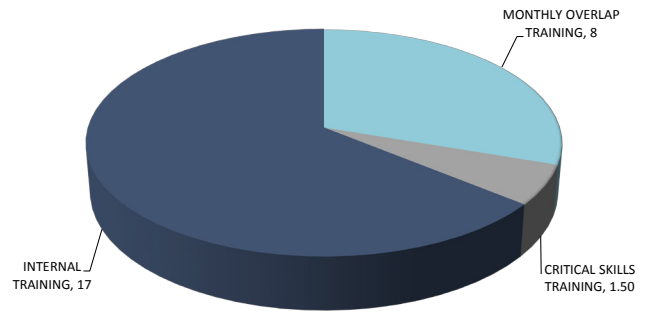

JANUARY 2017

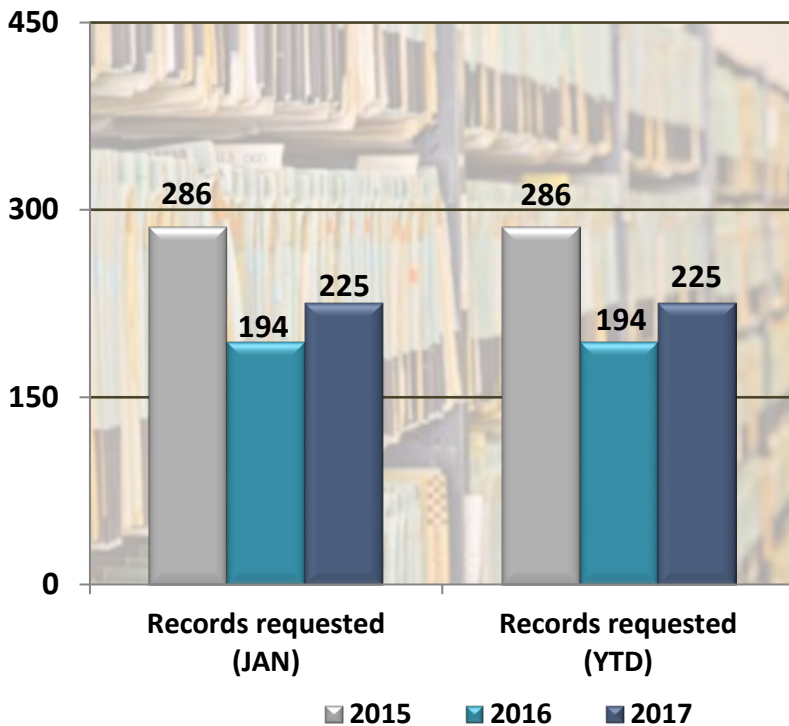


TRAINING HOURS BY CATEGORY

JANUARY 2017

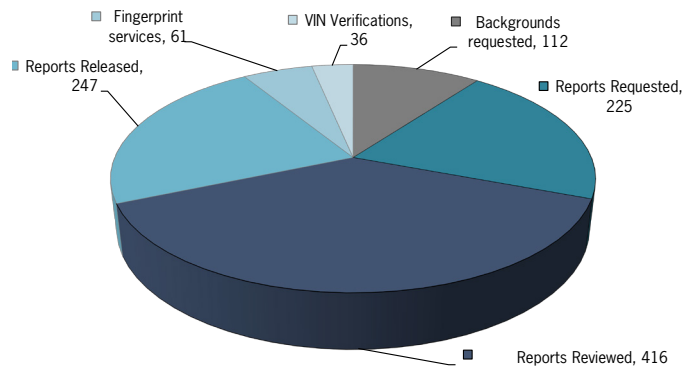


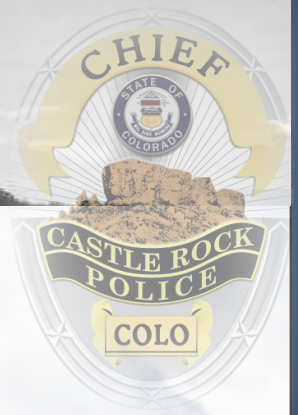
