

**SUMMARY OF EACH REQUEST FOR THE 2016  
PHILIP S. MILLER RESOURCE GRANT PROGRAM**

**DOUGLAS/ELBERT TASK FORCE - 501(c)(3)**

**REQUEST: \$20,000**

**REQUEST FOR NECESSITIES OF LIFE:**

The request is to purchase food for the D/ETF Food Bank.

**SERVES SIGNIFICANT PERCENTAGE OF CR RESIDENTS:**

In 2014, the Task Force assisted 15,500 people of which approximately 65% were Castle Rock residents.

**ADDITIONAL FUNDING SOURCES:**

The Douglas/Elbert Task Force receives support from the local Castle Rock community, City of Lone Tree, Douglas County and Elbert County Social Services. They recently established relationships with both WalMart and King Soopers in order to increase food donations for the food bank.

**ABILITY TO PRODUCE MEASURABLE RESULTS:**

D/ETF tracks the amount of food/hygiene items provided on a daily log. The log also records pounds of food, value of clothing provided and monies contributed toward rent and utilities. Copies of the facts sheets are available at the D/ETF offices for review or dissemination.

**CRISIS CENTER - 501(c)(3)**

**REQUEST: \$20,000**

**REQUEST FOR NECESSITIES OF LIFE:**

To provide operational support for the 28-bed Emergency Shelter and specifically to provide safe and confidential housing, food and other support essential to victims of domestic violence.

**SERVES SIGNIFICANT PERCENTAGE OF CR RESIDENTS:**

In 2014, the agency provided over 7,400 nights of safe shelter and assisted over 10,000 people, of which more than 25% were from Castle Rock. The Center was forced to turn away approximately 400 individuals in 2014.

**ADDITIONAL FUNDING SOURCES:**

Continue to focus on building relationships with new and existing donors and diversifying their income sources to meet the required need.

**ABILITY TO PRODUCE MEASURABLE RESULTS:**

All programs are constantly evaluated through statistical monthly reporting. 90% of clients continuing in the transitional program after their shelter stay avoided returning to a violent relationship.

**SKY CLIFF CENTER – ADULT DAY CARE SERVICES AND STROKE  
SUPPORT GROUP - 501(c)(3)**

**REQUEST: \$10,000**

**REQUEST FOR NECESSITIES OF LIFE:**

Provide shelter and food for participants and help offset the loss of income due to accepting Medicaid payments.

**SERVES SIGNIFICANT PERCENTAGE OF CR RESIDENTS:**

Within the town of Castle Rock, there is a limited availability of resources to serve the daily needs of adults with disabilities. Sky Cliff has attempted to fill this growing need. There are 40 participants enrolled in the day care program – 60% are Castle Rock residents. The Stroke Victim's Support Group has 70 participants – 71% are Castle Rock residents

**ADDITIONAL FUNDING SOURCES:**

Other grants and fund drives

**ABILITY TO PRODUCE MEASURABLE RESULTS:**

Success will be measured by the increase in the number of individuals they are able to help. Results will be published in the Sky Cliff Connections newsletter.

**HABITAT FOR HUMANITY OF METRO DENVER - 501(c)(3)**

**REQUEST: \$20,000**

**REQUEST FOR NECESSITIES OF LIFE:**

Home ownership program that builds and repairs affordable homes in partnership with low-income families.

**SERVES SIGNIFICANT PERCENTAGE OF CR RESIDENTS:**

Habitat has built 600 homes in five metro counties over 36 years; however, no homes have been built in Castle Rock. Recently, they have purchased a condominium on S. Gilbert Way. The new homeowner of this condominium may or may not be a current resident from Castle Rock.

**ADDITIONAL FUNDING SOURCES:**

Individual and corporate donations, home sponsorships, public and private grants, in-kind labor and materials donations, fundraising events and net proceeds of the ReStore home improvement outlets

**ABILITY TO PRODUCE MEASURABLE RESULTS:**

Production of an additional decent and affordable housing unit for the Town of Castle Rock, and the introduction of an additional hardworking and stable homeowner and their family to the community.
