Representatives from Clothes to Kids of Denver, Castle View High School's Technology Student Association Chapter, Denver Regional Mobility and Access Council, and Castle Rock Community Band spoke to explain their programs and thank Council.

DIR 2023-027

Discussion/Direction: Town Code Provisions Concerning Public Indecency

Mike Hyman, Town Attorney, presented the proposed Code amendments. Hyman recommends that we adopt the state public indecency law and indecent exposure law and exclude the felony enhancement provision as a felony is not prosecutable in municipal court. Public nudity has not been criminalized at the state level, as it is left up to the municipalities. Hyman recommends they do not include breasts in intimate parts and only simulated parts below the waist.

Citizens that addressed Council:

Anya Zavadil and Jay Griebling stated it has been a contentious year with hateful speech that grows the division. As a Christian, Jay said he sat down with Anya and apologized for his past remarks. They agreed on what kids should not be exposed to. Jay felt that Jimmy Graham's group held a peaceful protest. Anya feels they can search for common ground even if they do not agree with all of his views and they will be respectful of their neighbors and wants to ensure any new laws are not discriminatory.

Dana Bonham - stated that Pridefest is not the target but the catalyst of the ordinance. The parasol patrol confronted the lady she was with and she felt bullied and intimidated by people following them and taking pictures in their face. She added that Michael Clarkson was shouting her name. Bonham witnessed men peacefully protesting, and were insulted and yelled at with expletives; and they only replied with "I love you". She stated the parasol patrol said it would be nice to have daggers on the end of their parasols. Bonham reported that they were not inclusive, were grabbing their private parts in front of everyone, there was intimidation and bullying, and that it was not family friendly.

Brooke Bernstein - she announced that she has two trans kids that are normal and healthy and are transitioning. She complimented the legal team.

Mandy Mouw - she stated she has worked in the mental health field for over 20 years, and that studies show that early exposure to sexuality affects children by increased confusion, insecurity, hypersexuality, etc. She has worked with LBGTQ, furries, 3 year olds of the opposite sex, etc.; and found that the traditional lesbian and gay members are well adjusted. She stated there are high incidents of mental health issues and suicide in other members of the community from perpetuating gender confusion.

KC Neel - thanked Council for their service and making decisions that affect people. Legal has done a good job We don't have an indecency problem here, and asked if it is just men in women's clothing that is offensive. She feels core conservative principals are for less regulation not more.

Brad Berkford - represents a group of Castle Rock residents that feel it is important to protect children from indecent exposure and thanked Mike Hyman who put together his proposal, and feels the exposure of intimate parts of the body should include simulations. He is concerned that people could claim nudity is protected by free speech or worship. and asks that it be struck.

Mary Wilson - stated it isn't about indecency it is about sexual identify and how people express themselves and feels it is confusing what it means to be indecent. She feels the protest was not about protecting kids, it was to model male masculinity, and it is treading on the rights of a parent and where parents can take their kids.

Pam Long - speaking as a veteran and as a mental health professional stated she is required to notify authorities of suspected child abuse. She stated that gender disphoria is defined as a mental illness and children must be protected from people with mental illness. It is a clinical diagnosis. She asked to conduct a risk assessment.

Chad Cox - spoke two weeks ago and that video taped the event. He felt Cavey put his family at risk because she asked for prayers as she attended Pridefest.

Councilmember LaFleur stated that this topic is not appropriate for us to focus only on one group.

Councilmember Dietz stated they are not targeting one group.. Council came together and agrees.

Councilmember Hollingshead didn't feel this was necessary and felt it turned an event into a horrible scene that didn't need to happen. This law is not banning people from being transgender or drag. He said the ordinance only states don't have sex or show your genitals in public.

Mayor Pro Tem Bracken is glad this is over and we can put it behind us. We listened, we heard, we sat through meetings saying the same thing over and over again.

Moved by Councilmember LaFleur, seconded by Councilmember Hollingshead to Direct Staff to prepare an Ordinance Concerning Public Indecency, Indecent Exposure and Nudity as presented and amend all Town policies, permits and

Discussion/Direction: Council Meeting Time Protocols

David Corliss, Town Manager, provided a summary of extended meetings over the past 5 years. Any change will require a code amendment.

Councilmember LaFleur and Councilmember Cavey agreed to vote at 9:30 to continue the meeting until it ends without having to do two or more votes.

Councilmember Dietz inquired if they should allow 45 minutes at the beginning of the meeting for unscheduled public comment.

Corliss wants to ensure we get to people with scheduled items.

Councilmember Hollingshead asked if they could play it by ear if there are a lot of people to speak and how much time they allow at the beginning.

Corliss said they accept the agenda, so a Councilmember could propose more public comment time.

Citizens that addressed Council:

Brad Berkford - feels it is important that members of community get to speak to Council - this is the only way. There were two people that testified tonight that they came together as a result of public comment.

Dana Bonham - She emailed Council on August 26 and never got a response, and wanted to address how they call citizens to speak, and it was an issue if one Councilmember doesn't agree to extend the meeting, then speakers waited in vain. She feels listening to citizens is part of their job. She signed up online during a break at work because the website states to sign up by 1pm to speak, but she was not called on all night even after staying late.

She feels if you sign up online, you should be guaranteed to speak.

Charcie Russell - She noted they had a packed house and that is a good thing for people that never came to Council before. She stated Council is here for the citizens, and they are here for them. She is happy they resolved things tonight and is glad that Pridefest didn't have sexualized behavior this year.

Moved by Councilmember LaFleur, seconded by Councilmember Dietz, to Direct staff to prepare an ordinance to change the Town Code to require a simple majority vote at 9:30 pm to extend the meeting to complete the agenda. The motion passed by a vote of:
