

RESOLUTION NO. 2016-057

**A RESOLUTION SETTING THE DATE FOR AN ELECTION PURSUANT TO
STATUTORY MANDATE FOR THE PURPOSE OF SUBMITTING TO THE
REGISTERED ELECTORS OF TOWN COUNCIL DISTRICT NO. 1 THE QUESTION
OF WHETHER DISTRICT NO. 1 COUNCILMEMBER PAUL DONAHUE SHOULD BE
RECALLED FROM OFFICE AND PRESCRIBING THE MANNER BY WHICH SUCH
ELECTION SHALL BE CONDUCTED**

WHEREAS, by adoption of this Resolution the Town Council fulfills its obligations related to the recall of a municipal official under Section 4, Article XXI of the Colorado Constitution, Section 15-3 of the Town Charter and §31-4-501, *et. seq.* of the Colorado Revised Statutes,

WHEREAS, pursuant to §31-4-503(4) C.R.S., on May 2, 2016 the Town Clerk issued her certification that the “PETITION TO RECALL PAUL DONAHUE FROM THE OFFICE OF COUNCILMEMBER FOR THE TOWN OF CASTLE ROCK” (“Petition”) was legally sufficient under the Town Home Rule Charter and applicable statutory requirements as to form and required signatures (“Certification”),

WHEREAS, such statutory provision requires that the Town Clerk submit such Certification and a copy of the Petition to the Town Council at the regular Town Council meeting on May 3, 2016, which is the first Council meeting following Hearing Officer Karen Goldman’s May 2, 2016 “Final Determination and Conclusion” denying all protests to the Town Clerk’s finding of Petition sufficiency dated April 11, 2016,

WHEREAS, §31-4-503(4) mandates that upon submission of the Certification by the Town Clerk, the Town Council shall thereupon (i) fix a date for the recall election to be held not less than thirty days and not more than ninety days from May 3, 2016, and (ii) determine whether voting at the recall election shall take place at a polling place or by mail ballot, and

WHEREAS, it is necessary and proper for the Town Council to address election procedures and other matters related to the conduct of such recall election,

**NOW, THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE
TOWN OF CASTLE ROCK, COLORADO AS FOLLOWS:**

Section 1. Submission of Clerk’s Certification and Recall Petition. The Town Council acknowledges receipt of the Town Clerk’s Certification, attached as *Exhibit A*, and the Petition which is Exhibit 4 to the Certification.

Section 2. Call of the Recall Election. A mail ballot election on the recall of Councilmember Paul Donahue shall be held on Tuesday, July 26, 2016 (“Recall Election”). Only eligible voters within District No. 1 shall have the right to vote in the Recall Election.

Section 3. Conduct of the Recall Election. The Recall Election shall be governed by and conducted in conformance with the “Uniform Election Code of 1992” as a recall election and pursuant to an Intergovernmental Agreement between Douglas County Clerk and Recorder and the Town of Castle Rock (“IGA”). Town officials are authorized to negotiate and execute the IGA in the form required by the Douglas County Clerk and Recorder.

Section 4. Ballot Form. The ballot title and question for the Recall Election shall read as follows:

The reasons set forth in the petition for demanding the recall of Councilmember Paul Donahue:

This Petition to Recall is based on the leadership style and voting record of Paul Donahue which we believe have been detrimental to the health of our community. In Council, he has lead an agenda to suppress voices of those with whom he disagrees yet took an oath to represent. Specifically, he has dramatically reduced allotted time for public comment and in some instances denied citizens the opportunity to speak at all. He has shown deference to out-of-town developers and citizens who support his personal and political interests. His voting record includes: supporting a rate of development that arguably exceeds infrastructure and environmental sustainability, voting for a reduction in public comment during City Council meetings, and rejecting grant monies that would benefit Castle Rock senior citizens and families in crisis. The success of this petition will provide an opportunity for a different style of leadership on City Council that genuinely encourages active citizenry and more clearly protects the quality of life for all Castle Rock citizens.

Section 6. Effective Date. This Resolution shall take effect upon its adoption on first and final reading.



Dear Ms. Hackett, Ms. Reeves and Mr. Buckley:

This letter is in response to the form petition to recall the above-referenced officer of the Town of Castle Rock, which was submitted on Thursday, March 10, 2016. Pursuant to C.R.S. § 31-4-502(1)(c), I have reviewed the form of the petition to determine whether it meets the requirements of C.R.S. § 31-4-502.

You are hereby advised the petition form is APPROVED, and authorized for circulation.

Section 15-3 of the Town Charter requires a recall petition be signed by registered electors of the district from which the Councilmember sought to be recalled was elected, in an amount that is twenty-five percent (25%) of the entire vote cast at the last preceding election for all candidates for the office which the Councilmember occupies. There were 587 votes cast for Councilmember for District 1 at the last preceding election at which a Councilmember from District 1 was elected. Therefore, this petition will require at least 147 valid signatures for it to be deemed sufficient pursuant to the Town's Charter.

Please be aware of the following with regard to petition circulation: Section 15-3(c) of the Town Charter provides that no signature on a recall petition shall be valid if signed on a date more than thirty days prior to the date the signed petition is filed with the Clerk; pursuant to C.R.S. § 31-4-502(1)(c), any petition signatures dated prior to March 10, 2016 shall not be valid; and in accordance with C.R.S. § 31-4-503(2)(d), any disassembly of the petition that has the effect of separating the affidavits from the signatures shall render the petition invalid and of no force and effect. Note the petition must be stapled prior to circulation.

The Town Clerk's Department has finished its review of the petition signatures submitted on April 6, 2016 for the Petition to Recall District 1 Councilmember Paul Donahue.

The Town Clerk determined a sufficient number of valid signatures have been submitted. Pursuant to the Town Charter, a minimum of 147 valid signatures were required; the petition contained a total of 242 valid signatures.

Following passage of: (i) the period of time within which a protest may be filed pursuant to C.R.S. 31-4-503 (April 21, 2016); or (ii) the date on which any protest proceeding is concluded and a ruling issued, whichever is later, a final determination as to the petition's sufficiency will be issued.

FINDINGS OF FACTS AND CONCLUSION PETITION TO RECALL PAUL DONOHUE FROM THE OFFICE OF COUNCILMEMBER FOR THE TOWN OF CASTLE ROCK

An administrative hearing on protestS to the petition to recall Paul Donohue from the office of Councilmember for the Town of Castle Rock was held on Thursday, April 28, 2016 at 10:05 a.m. in the Castle Rock Town Hall. The Hearing Officer was Karen Goldman, duty appointed by the Castle Rock Town Council.

Administrative Notice was taken of the following documents:

1. The Town Clerk's letter approving the form of the petition to recall Mayor Paul Donahue dated March 10, 2016.
2. The signed recall petition filed with the Town Clerk's office on April 6, 2016.
3. The Town Clerk's initial determination of petition sufficiency dated April 11, 2016.
4. Letters of protest filed by:
 - a. Kira James dated April 18, 2016
 - b. Lana J. Wagner dated April 21, 2016
 - c. Langford Jordan dated April 21, 2016
 - d. Rebecca L. Smoldt dated April 21, 2016
 - e. Jeff Samuelson dated April 21, 2016
 - f. Arielle Clay dated April 21, 2016
 - g. Attorney Abraham J. Laydon dated April 21, 2016
 - h. Paul Donahue dated April 21, 2016
 - i. Lori Makkai dated April 21, 2016
5. The notices of protest hearing dated April 19 and April 22, 2016
6. The Douglas County, Colorado, voter registration list dated April 27, 2016.

Attorney Abraham J. Laydon was in attendance to represent Paul Donahue.

Attorney Paul L. Hackett was in attendance to represent petitioner Suzanne Hackett.

The subjects for protest generally related to four areas:

1. The grounds set forth in the petition on which recall was sought
2. The expenditure of funds for a recall election
3. The petitions being circulated or signed under the influence of alcohol
4. The challenges to the circulator affidavits

Testimony on each of the subject areas was taken separately and witnesses were placed under oath.

TESTIMONY ON THE GROUNDS ON WHICH RECALL WAS SOUGHT

1. Jeff Samuelson, a protester, identified himself as a commercial broker in Castle Rock and stated that the recall was based on a vote by Paul Donahue that denied funds to be used by certain groups and that not all the facts in

the matter had been provided. Upon questioning, he stated it was his interpretation that the petitioners were stating that the money would instead go to other places with government control. Upon further questioning, Mr. Samuelson stated he was never presented with the petition and that he did not reside in District 1, the district represented by Paul Donahue. He said he had not seen or read the petition, rather he had just seen the petition posted online.

2. Arielle Clay, a protester, stated she was protesting the petition on the issue of growth and that the current growth plan had been in place long before Mayor Donahue came to office. She said the petition had not been presented to her personally, she did live in District 1, and she had seen the petitions 'out there'.
3. Lori Makkai, a protester, stated she had not been presented with or had seen the original petition, but had seen a copy online. She testified she was protesting the validity of the petitions, especially the statement that Paul Donahue had voted to shorten the time allotted to speak at Council meetings, which was only shortened a little bit. She stated she did not live in District 1 and was aware that people who didn't live in District 1 had signed the petition, although she had no knowledge of any individuals who had done so. She said she was also told people signed the petition without reading it.

TESTIMONY ON THE EXPENDITURE OF FUNDS FOR A RECALL ELECTION

1. Kira James, a protester, stated that the Mayor's term of office would be up in November 2016 and therefore it was a waste of time and money to hold an election to recall him. Upon questioning, Ms. James guessed that a recall election would cost \$10,000 and that this was not an adequate use of taxpayer funds. Upon further questioning, she stated that even if Paul Donahue resigned his office, thereby cancelling the need for a recall election, it would still cost the taxpayers money in terms of staff time.
2. Arielle Clay, a protester, stated she agreed with the previous witness's testimony regarding both the waste of taxpayer money and the cost of a recall election. She said it was not an appropriate use of taxpayer funds.
3. Lori Makkai, a protester, stated she believed a recall election would cost between \$10,000 and \$60,000, that this also be a waste of taxpayer funds, and that she did not want to see town spend money to 'make a point'.

TESTIMONY ON THE PETITIONS BEING CIRCULATED OR SIGNED UNDER THE INFLUENCE OF ALCOHOL

1. Rebecca L. Smoldt, a protester, stated she had seen a Facebook posting by Stacey Rogers stating that she was at Maddie's Biergarten collecting signatures. Ms. Smoldt stated that she believed that to be a questionable

approach to collecting signatures and that the recall had created a rift in the town. She stated her belief that a recall should be in response to an emergency situation, to corruption, and not because people didn't like the way someone voted. She stated that integrity in the signature collection process was important, which meant meeting with people at a place where they can think through all the information. A bar at 8:00 p.m. on a Friday night was not an appropriate place. Upon questioning, Ms. Smoldt stated she had not been at the bar when the Facebook posting has been made nor had any first-hand knowledge of what went on there. She further testified that she did not know who may have signed the recall petition in the bar.

2. Lana J. Wagner, a protester, stated the method Ms. Rogers used to collect signatures, that is, while they were drinking may be the reason why some people are not saying they didn't know they were signing a recall petition. Upon questioning, Ms. Wagner stated she was not at the bar or had seen anyone sign the petitions at the bar, rather, she had been involved with someone who was recanting his/her signature.

TESTIMONY ON THE CHALLENGES TO THE CIRCULATOR AFFIDAVITS

1. Paul Donahue, subject of the recall petition, stated he had been Mayor for five years, that he had been elected to the Town Council three times, the first two unopposed, and that his term would end in November 2016. He further stated that he believed a recall election in District 1 would cost a minimum of \$10,000. He then stated that after the recall petitions had been turned in, he and his supporters had contacted 32 people who had signed the recall petition to find out what they had been told when presented with the petition. Mr. Donahue then presented notarized affidavits from 15 citizens, entered into the record as Exhibit 1, who said one or more of the following:
 - a. They were misled into signing the petition
 - b. They were not give an opportunity to read the petition
 - c. They questioned the motives of the petitioners
 - d. They were not aware they were signing a recall petition
 - e. The contents of the petition were misrepresented
 - f. They wished to remove their names from the petition
2. John Buckley, a petition representative, stated it was the actions of Paul Donahue that caused people to sign the recall petitions. He further stated that the reasons listed on the recall petition were valid and of concern, and if they hadn't been, the petitions would not have been circulated. In response to questioning, Mr. Buckley stated he had collected 100 signatures.

Mr. Buckley then asked that Stacey Rogers be permitted to testify.

3. Stacey Rogers testified that she was a petition circulator. She further stated that she did not collect any signatures at Mattie's Biergarten, that the affidavits she had signed on the recall petition sections she circulated were truthful and that she could write anything she wanted to say on Facebook.

She said that, when collecting signatures, all but two had been collected at people's homes. Upon questioning, Ms. Rogers stated that when collecting signatures, she did tell people that what she was circulating was a recall petition, then spoke about the grounds, including the reduction of speaking time at meetings, an increase in signature requirements for initiative and referendum petitions, and that Paul Donahue spoke of developers as 'customers'. Upon further questioning as to the number of people who actually read the petition she presented, she said that she saw every person's eyes moving over the front page of the petition and thus assumed that every person had read it.

4. Suzanne Hackett, a petition representative, stated she was following the letter of the law when circulating the recall petition. She said the first thing she said was that she was circulating a recall petition. She also said she first showed them the first page of the petition, which contained the grounds for recall, and believed that everybody read the petition. She said she didn't believe people had been misled into signing the petition.

ADDITIONAL TESTIMONY

1. Kira James, a protestor, said she believed that people didn't understand the cost for a recall election.
2. Lana J. Wagner, a protester, stated that Paul Donahue was only one of the Council members who voted to reduce the time allotted for the public to speak at meetings as well as other votes. Other Council members voted on this as well, so she couldn't understand why he had been singled out. She stated a recall election would squander thousands of dollars on the recall election when Mayor Donahue's term would end in November when the regular election would be held. She also stated that she had seen the posting on Stacey Rogers' Facebook page and felt it was not appropriate to collect signatures in a bar when people might be inebriated.
3. John Buckley, a petition representative, stated that if Paul Donahue resigned, the town would be spared the cost of a recall election.

CLOSING STATEMENTS BY ABRAHAM J. LAYDON

Mr. Laydon stated there had been sufficient testimony to invalidate the petitions. He said he believed collecting petitions in a bar was a significant incident, that the circulators had misled the voters and misrepresented the nature of the petition to citizens, in violation of the provisions of the affidavit, and that the cost of an election to recall someone who is term-limited in November was preposterous. He also noted that Mr. Donahue would not be resigning.

CLOSING STATEMENTS BY PAUL L. HACKETT

Mr. Hackett stated his sense that democracy has some costs associated with it. He noted that 31-4-502, C.R.S., stated that the grounds on a recall petition were for the purpose of providing information for the electors, who were the sole judges of them and further that the grounds are not subject to review. He also stated his belief that the affidavits from the 15 citizens who felt they had been misled were 'suspect'. He noted that there had been no evidence of petition failure presented by Mr. Laydon in accordance with 31-4-503(b), C.R.S. and also noted 31-4-503(3)(a) which prohibits the removal of signatures once recall petitions had been filed with the clerk. He stated that the petitions more than met the requirements of state law and asked that the voters speak their minds in a recall election.

DISCUSSION ON THE GROUNDS ON WHICH RECALL WAS SOUGHT

Municipal recall is governed by the procedures in Article 4 of Title 31, the Municipal Election Code of 1965. 31-4-502, C.R.S. describes the information that shall be included on a recall petition. including a demand for the election of a successor (note that the Castle Rock town charter requires the appointment of a successor), the names and addresses of between three and five persons who represent the signers of the petition, and the name of the municipality and the person to be recalled. Additionally, this statute states:

The petition shall contain a general statement, in not more than two hundred words, of the grounds on which the recall is sought, which statement shall be intended for the information of the electors of the municipality. Such electors shall be the sole and exclusive judges of the legality, reasonableness, and sufficiency of the grounds assigned for recall, and said grounds shall not be open to review.

The protests of Jeff Samuelson, Arielle Clay, and Lori Makkai were based on their opinions that the grounds for the protest were, if not false, at least incomplete. None of the protesters were presented with a petition and two of them, Mr. Samuelson and Ms. Makkai, did not live in District 1 and could not have signed the petition if it had been presented to them.

State law does not restrict the circumstances under which electors can initiate the recall of an elected official. While some people believe a recall should only be used in situations of corruption, malfeasance, or other 'major' wrongful activities, the reality is that a recall can be demanded for any reason whatsoever. Recall petitioners are allowed to include on the recall petition a statement of the reasons for such recall, known as the 'grounds' solely for the purpose of informing the electors why the recall is being sought and to enable them to choose to sign such petition. It should be noted that, should the recall petition be deemed to be sufficient and a recall election set, the person sought to be recalled is then permitted to submit a written response and both the petitioner grounds and the response appear on the ballot. Again, the purpose of these statements is to enable the voters to make their decision at the ballot box.

State law is very clear on the purpose of the grounds: they are intended for information only. It is up to the electors of Castle Rock, and not just those who signed the petition, to determine whether the grounds are legal, reasonable, and sufficient to result in a recall. State law is also very clear that the grounds 'shall not be open to review'.

The protest on the grounds on which recall is sought is thus denied.

DISCUSSION ON THE EXPENDITURE OF FUNDS FOR A RECALL ELECTION

Title 31 specifies the dates on which a municipality may hold its regular municipal election, and a regular municipal election is generally defined as the date on which persons are elected to municipal office. The voters of the Town of Castle Rock recently changed the date of their regular municipal election to November of even-numbered years and one result of that change is that the town will now be able to coordinate its election with its county clerk and recorder in Douglas County. Approximately 100 municipalities in Colorado coordinate their regular municipal elections.

Colorado municipalities can also conduct special municipal elections as provided by 31-10-108, C.R.S., *on any Tuesday designated by ordinance or resolution of the governing body*, with certain dates blacked out due to their proximity to other regularly-scheduled statewide elections. A special municipal election on the proposed recall could be scheduled so as not to conflict with the blacked-out dates.

Protests by Ms. Kira James, Ms. Arielle Clay, Ms. Lori Makkai, and Ms. Lana J. Wagner were based on the fact that a recall election would cost approximately \$10,000 to conduct which was, in their opinions, a waste of taxpayer funds when the person subject to recall, Mayor Paul Donahue, would be term-limited in November 2016.

Nowhere in the statute concerning special municipal elections nor in any other portion of Title 31 is there a prohibition against holding a special municipal election due to its cost. While it may be a municipal expenditure that no one was expecting (and some don't desire), the recall process is a democratic election process and once underway, concern about the cost of the election, while understandable, cannot stop it.

The protest on the expenditure of funds for a recall election is denied.

DISCUSSION ON THE PETITIONS BEING CIRCULATED OR SIGNED UNDER THE INFLUENCE OF ALCOHOL

The protests of Rebecca L. Smoldt and Lana J. Wagner were based on a posting they had read on Stacey Rogers' Facebook page that she was collecting recall petition signatures at Mattie's Biergarten. Ms. Smoldt questioned the legality of the collection approach and stated her opinion that it was questionable. Ms. Wagner stated that on Ms. Rogers' Facebook page, she said she could not verify the

soberness of the signers. Ms. Smoldt later stated she was not present at Mattie's Biergarten when the signatures were supposedly being collected nor did she know of anyone who had signed Ms. Rogers' petitions while in that location. Ms. Wagner stated she also was not at the bar when signatures were being collected nor did she know of anyone who signed in the bar.

Upon later questioning, Ms. Rogers' testified that she did not collect any petition signatures at that location and that she could post anything she wanted on her Facebook page. No evidence or testimony was provided from anyone who had signed the petition in Mattie's Biergarten or from anyone who had seen someone sign the petition there. Finally, no statute or legal argument was presented that would show the ability to collect signatures in a bar, however questionable it might appear to some people, was an illegal act.

The protest on the petitions being circulated or signed under the influence of alcohol is denied.

DISCUSSION ON THE CHALLENGES TO THE CIRCULATOR AFFIDAVITS

Mayor Paul Donahue, the subject of the recall petition, stated that the recall petition circulators had made certain misrepresentations to the signers of the petition, in violation of the affidavit of circulator. He stated that he and some of his supporters had contacted approximately 32 persons who had signed the petition and submitted sworn affidavits from 15 persons who stated that one of the following had occurred: they were misled into signing the petition; they were not given an opportunity to read the petition; they questioned the motives of the petitioners; they were not aware they were signing a recall petition; the contents of the petition were misrepresented; and, they wished to remove their names from the petition.

Mr. John Buckley, Ms. Stacey Rogers, and Ms. Suzanne Hackett were all questioned as to what they told citizens when they approached them to sign the recall petitions, whether they stated they were circulating a recall petition, whether they accurately reflected the purpose of the recall in their discussion with the citizens, whether they saw citizens reading the petition before they signed it, and, if so, how many citizens did that.

Mr. Buckley responded that he believed the reasons for the recall were valid and of concern. Ms. Rogers stated that when collecting signatures, she did tell people what she was circulating was a recall petition, then spoke about the grounds. Upon further questioning as to the number of people who actually read the petition she presented, she said that she saw every person's eyes moving over the front page of the petition and thus assumed that every person had read it. Ms. Hackett stated she was following the letter of the law when circulating the recall petition. She said the first thing she said was that she was circulating a recall petition. She also said she first showed them the first page of the petition, which contained the grounds for recall, and believed that everybody read the petition.

31-4-502(1)(a)(II) and (b) identifies certain information that must appear at the top of every page of a recall petition as follows:

WARNING: IT IS AGAINST THE LAW:

For anyone to sign this petition with any name other than one's own or to knowingly sign one's name more than once for the same measure or to sign such petition when not a registered elector.

Do not sign this petition unless you are a registered elector. To be a registered elector, you must be a citizen of Colorado and registered to vote in (name of municipality).

Do not sign this petition unless you have read or have had read to you the proposed measure in its entirety and understand its meaning.

(b) Directly following the warning in paragraph (a) of this subsection (1) shall be printed in bold-faced type the following:

Petition to recall (name of person sought to be recalled) from the office of (title of office).

In reviewing the recall petitions, a warning (in bold type) did appear on every page of the recall petition and a statement (also in bold type): **'PETITION TO RECALL PAUL DONAHUE FROM THE OFFICE OF COUNCILMEMBER FOR THE TOWN OF CASTLE ROCK'** also appeared on the first page of each petition, after the warning and before grounds for recall.

The third statement following the warning is very clear; it admonishes people not to sign the petition unless they have read it or have had it read to them in its entirety and they understand its meaning. This places the burden on the signers rather than on the circulators. Despite Ms. Rogers' and Ms. Hackett's statements that they believed *every single person* (emphasis added) who signed their petitions had read it, it is more realistic to believe that persons signed the petition based on what they were told, rather than what they had read, and that they agreed with what they had been told or they at least did not disagree. And if what they had been told was exaggerated or embellished by the petition circulators, what they were told was the petition circulators' beliefs about the specific matters that led to the creation of the grounds. No evidence or testimony was presented that showed the statements provided by the petition circulators, even if exaggerated, were made with the deliberate intent to mislead potential signers.

No evidence or testimony was presented as to what Mayor Donahue's supporters said to the 15 persons who submitted affidavits after they had signed the recall petition and the petition had been submitted for review to elicit their affidavits. However, the time to be cautious and to be concerned about the potential for being misled should have been prior to signing the petition and not after.


Some of the 15 people submitting affidavits asked that their signatures be removed from the petition. 31-4-503(3)(a), C.R.S. is quite clear: *The clerk shall not remove the signature of an elector from the petition after such petition is filed.*

The protest on the challenges to the circulator affidavits is denied.

FINAL DETERMINATION AND CONCLUSION

31-4-503(3)(b) states in part: *Grounds for protest may include, but shall not be limited to, the failure of any portion of a petition or circulator affidavit or petition circulator to meet the requirements of this section.* No credible evidence of petition failure was presented during this administration hearing on the part of any of the protests.

Therefore, it is determined that the petition to recall Mayor Paul Donahue is sufficient.
