

**RESOLUTION NO. 2025-157**

**A RESOLUTION APPROVING AN ON-CALL EQUIPMENT AND SERVICES ACQUISITION AGREEMENT WITH TREATMENT TECHNOLOGY HOLDING, LLC**

**WHEREAS**, the Town of Castle Rock, Colorado (the “Town”) has identified the need for a contractor to supply various chemicals required for water treatment at its treatment plants (“Project”) to ensure the continued delivery of safe and reliable water service to the Town residents; and

**WHEREAS**, the Town issued a formal Invitation for Bid (IFB) from qualified contractors for the Project;

**WHEREAS**, the Project selection team has determined that Treatment Technology Holding, LLC (the “Contractor”) is best qualified to perform work for the Project; and

**WHEREAS**, the Town and Contractor have agreed to the terms and conditions by which the Contractor will provide work for the Project (the “Agreement”).

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF CASTLE ROCK, COLORADO AS FOLLOWS:**

**Section 1. Agreement Approval.** The Agreement between the Town and the Contractor is hereby approved in substantially the same form as presented at tonight’s meeting, with such technical changes, additions, modifications, deletions, or amendments as the Town Manager may approve upon consultation with the Town Attorney. The Mayor and other proper Town officials are hereby authorized to execute the Agreement and any technical amendments thereto by and on behalf of the Town.

**Section 2. Encumbrance and Authorization for Payment.** In order to meet the Town’s financial obligations under the Agreement, the Town Council authorizes the expenditure and payment in an amount not to exceed \$750,000.00, unless authorized in writing by the Town.
