There's no doubt that these events have created much interest in our town. Due to increased attendance, WineFest will be relocating to a larger venue in 2017 so look for updates soon.

The <u>Chamber website</u> was updated and I encourage you to check it out and see all the Chamber has to offer. It has been expanded and is easily navigable to find the resources you need. Feel free to share this wonderful wealth of information with your friends, employees and business contacts.

Provide Opportunities to Build Business Relationships

Business After Hours and Business Over Breakfast are just some of the networking opportunities for members to enjoy. These were well attended in 2016 and will likely grow in 2017. 



BUSINESS SERVICES

Castle Rock Chamber's **eXcelerate Business Development program** provides small businesses with the resources used by best-in-class firms, thereby enhancing their competitiveness in the local. state and global marketplaces.

The <u>CastleRock.org</u> website links to an electronic business tool kit. It's enhanced with Search Engine Optimization, video streaming and a business training calendar.

Tools include: Business Planning, Loan Payment Calculator, 750+ business books, new hire procedures, Employer's Kit, & a directory of sources of capital and updates on local business training opportunities.

WORKSITE WELLNESS

Facilitated the new Worksite Wellness Program in partnership with Health Links Colorado with the purpose to engage the business community to promote health, safety, and wellness in the workplace. Obtained \$15,000 grant for 12 Certified Businesses and 27 vendors as part of the program.

ONLINE TRAINING

This program specializes in providing a "one-stop shop" for individuals and organizations looking to purchase online training courses needed for certification, or to advance employee knowledge while at home, the office or even mobile.

ELECTRONIC JOB BOARD

New in 2016, the Chamber introduced a public job board for our members to post their employment opportunities. 78 jobs were posted in 2016. Popularity has increased with the addition of 2 new domains: CastleRockCareers.com and DouglasCountyJobs.com.

JOB FAIRS

In 2016 the chamber also added two Community Job Fairs. 79 businesses participated in the fair and 533 job seekers were in attendance.

PROMOTING OUR COMMUNITY THROUGH REGIONAL EVENTS

"Serving Douglas County"

A major component of community character and tourism has been identified by our residents as reasons why they love Castle Rock as these community events create a *home-town* atmosphere. The Chamber takes pride leading several of the community signature events with the assistance of the Town, Downtown Alliance and community volunteers.

Continuing in 2017, the Chamber will facilitate or partner with the following events:

- Douglas County Job Fairs— Our 2016 Job Fair was so successful we've added it to our list of annual events. With the purpose of raising awareness of employment opportunities in Douglas County, our next Douglas County Job Fair is 2/2/17.
 79 businesses participated and 533 job seekers attended in 2016.
- The Healthy Living Expo— a business expo which introduces businesses to our local and area residents. The goal is to promote a strong local economy by showcasing local and regional business products and services with a healthy twist to the residents of Castle Rock. 2016 event had 79 vendors, 2,706 in attendance. This event has since been renamed Douglas County Lifestyle Expo to broaden the scope/reach and will be held on 2/4/17.
- Victoria's Block Party—3rd Annual, a free community block party celebrates the history and heritage of the Chamber's historic building, Victoria's House, built in 1889. 2016 event had 600 attendees. 2017 date to be confirmed.
- Elephant Rock Ride—The Chamber partners with the ERock promoter by recruiting 24 non-profit organizations with aid station volunteers during this up to 100 mile bike ride with 6,025 riders in 2016. 29th Annual 6/4/17.
- Castle Rock WineFest—Colorado's eastern slope premier wine tasting event attracts wine lovers from the Front Range and from across the state. Encourages cultural activities and the promotion of Colorado wines which increases the economic impact to Castle Rock's local economy and marketing exposure. 3,688 attendees: 38% increase and 111 volunteers participated in 2016.
 - 14th Annual 7/15/17, Relocated to New location-Butterfield Park.
- Douglas County Fair Parade—A western styled parade which launched the creation
 of the Chamber of Commerce in 1955. The tradition of the parade is to act as the
 conclusion to the Douglas County Fair and Rodeo. A total of 81 entries, 3,198 parade
 participants and 10,845 spectators took part in 2016. This year the 61st Annual Fair
 Parade on 7/28/16 will kick off the fair.
- Colorado Artfest at Castle Rock—Juried fine arts show located in historic downtown is an end of summer tradition for residents and art enthusiasts alike. The festival experience includes interactive family activities, live main stage and strolling entertainment in addition to the beautiful original art created by 175 artists from around the country. Approximately 18,000+ people attended, with free admittance to all first responders/military on Sunday. 27th Annual event is 9/10 & 9/11/17.
- Starlighting—Premier signature event attracting residents, families and communities throughout Colorado founded on local community tradition and heritage which kicks off the holiday season and the lighting of The Star. Providing exposure to local business community. There were 73 non profits represented and 20,000 people in attendance in 2016. 81st Annual is 11/18/17.



POLITICAL ADVOCACY

GOVERNMENT INTERESTS COMMITTEE (GIC)

The Chamber's GIC group provides our business community with a proactive voice and advocate regarding local issues; and promotes economic interests, which contributes to the quality of life of Castle Rock. New in 2016, the Chamber hosted **3 Horizon Lunch Series events** to 162 attendees to inform the community on hot topics. The Chamber also held a **Candidate Forum**, which was videotaped/distributed, to educate the public on candidates running for Town Council.



DOUGLAS COUNTY BUSINESS ALLIANCE (DCBA)

Founded by the Castle Rock Chamber of Commerce, the **DCBA** and the **Government Issues Committee** advise our Chamber Board of issues affecting our business community. Four public issue forums and 43 committee interactions were conducted in 2016. These partnerships worked to influence decisions on legislative and local issues that affect business in Douglas County.

PROMOTING THE COMMUNITY

RELIABLE RESOURCES

Business directories, electronic sites, magazines, and area maps of Castle Rock and Douglas County are perfect for visitors to find key locations within our community. Our resources encourage loyalty by Castle Rock residents as a "first choice" shopping destination through advertising and partnership

with local media.
Again in 2016, the Chamber partnered with American Express and other community organizations to help promote
Shop Small Saturday. The Chamber

partnered in this campaign to educate the public on the importance of shopping local.



COMMUNITY MARKETING—New in 2016, the Chamber reignited a previous partnership with Journal Communications to publish the *Castle Rock Livability* magazine, formally *Images* magazine. Continuing in 2016, the Chamber partners with **Colorado Community Media** newspaper a full one-page monthly insert promoting the Chamber programs, our members, news and community events.

The Chamber, Town, DDA & County partnered to create a Community Events Mailer utilizing VisitCastleRock.org/Events as the 'official' Community Events Calendar—41.000 calendars were distributed.



SHOP THE ROCK WELCOME PACKETS

The distribution of Welcome Packets to new residents continues which includes demographics, local magazines, directories, maps, etc. Showcasing Castle Rock as a destination spot for shopping, dining and outdoor fun. 2,644 welcome packets were distributed in 2016.

VISITORS CENTER

Our Visitors Center, welcomed over 18,158 visitors in 2016. Extended hours included 13 Saturdays throughout the summer assisting an additional 196 visitors. Castle Rock boasts superior customer service that emanates from the hometown friendliness that comes naturally to folks in the area.



The Chamber's Visitors Center acts as the Town's one-stop shop for all things Castle Rock as well as a friendly, helpful face ready to assist their needs.

The large marquee on the corner of Fifth/Jerry stands as a landmark and visual aid to promote Chamber and Town happenings.

The new and improved <u>VisitCastleRock.org</u> website has increased awareness of local Castle Rock amenities for both residents and visitors by promoting community events and hospitality businesses.

Website traffic increased by 530% in 2016.

Implementing a new membership database software represents a **583% increase** in traffic to the Chamber's Business Directory at business.castlerock.org/list/.

In June, the Chamber launched a newly remodeled/upgraded website which has increased our web traffic by **12%**.

Social Media efforts were also increased representing a 57% increase on the Visit Castle Rock Facebook page and 15% increase on the Castle Rock Chamber page.


CASTLE ROCK ECONOMIC PARTNERSHIP


