

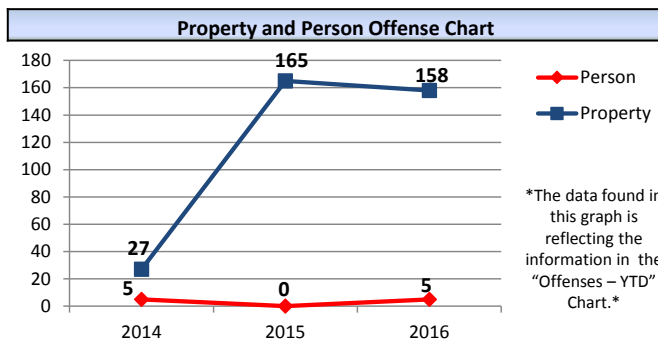

VEHICLE TRESPASS INFORMATION

In 2015, we had a total of 138 vehicle trespass reports. Multiple motor vehicle thefts occurred because the vehicle was left unlocked with the keys inside.

Within those 138 reports, there may be more than one vehicle that was trespassed. Many times people forget the items in their car, and they never become reported as stolen.

Of the vehicle trespasses that were reported and the stolen items that were recalled by victims, the total loss was approximately \$150,176. The majority of items stolen include tools, electronics, jewelry, purses/bags/wallets, and money.



REMINDERS:

- Lock your vehicle at all times.
- Park your vehicle in a garage as often as possible.
- Do not leave items out in plain view (it entices perpetrators).
- If possible, lock all registration, insurance and any other documents with personal information in the glove compartment.
- Try not to keep possessions in your vehicle. (To reduce your losses, remove money, jewelry and guns from the vehicle.)
- Try not to leave car/house keys within the vehicle.
- If the vehicle is left outside (with a garage opener inside), lock the door between your garage and home.

No liquor code inspections were conducted during the month of **MARCH**.

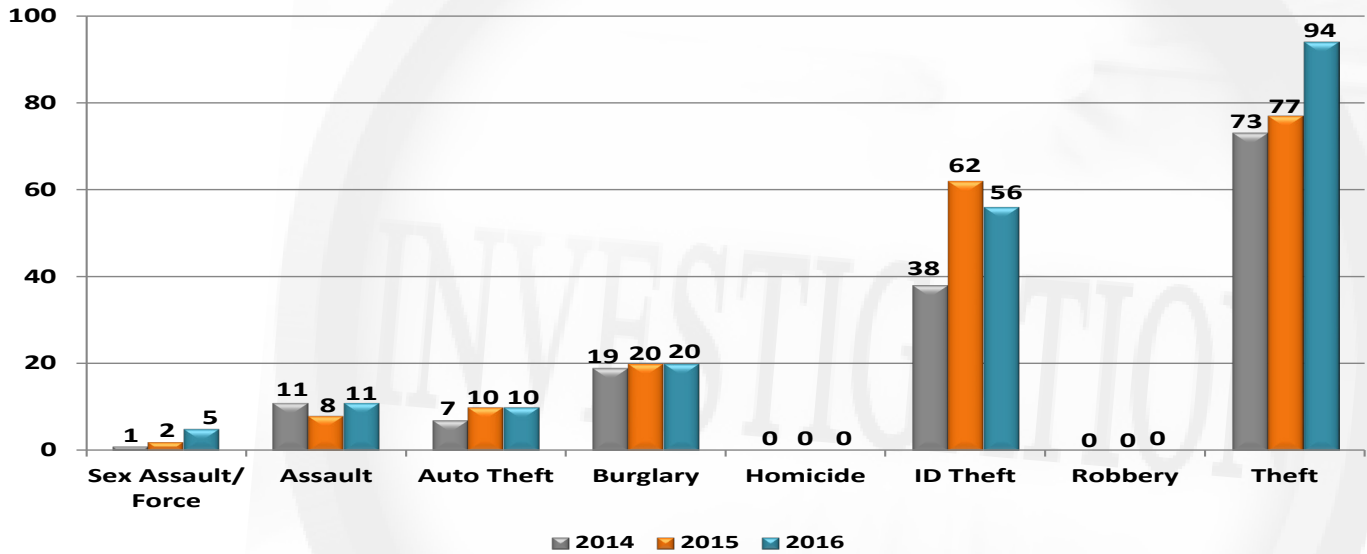




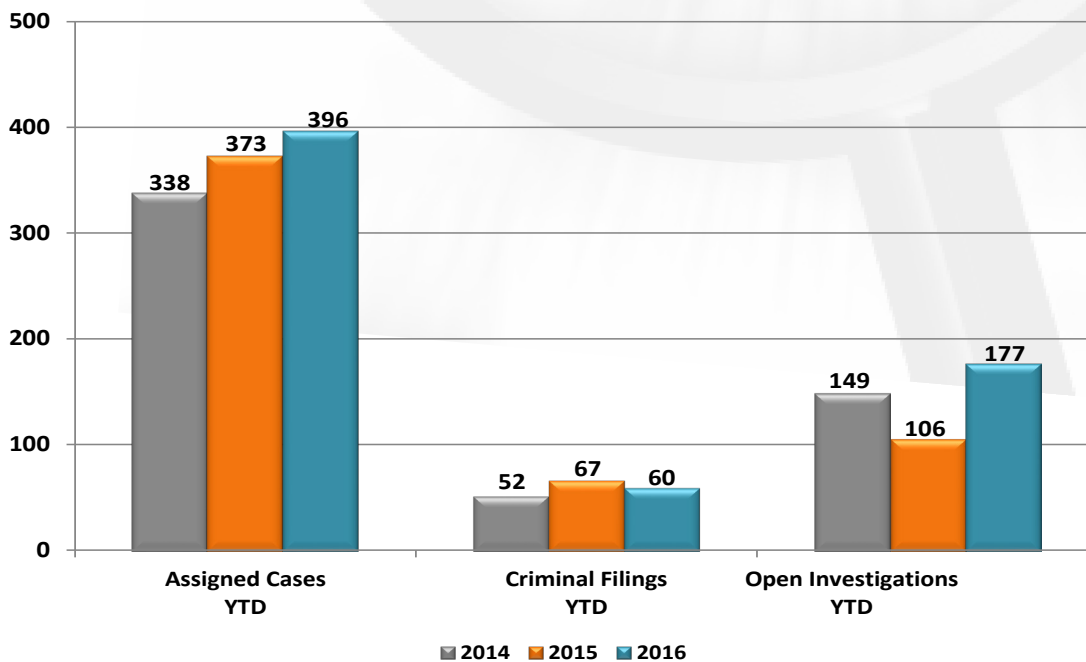
DETECTIVE UNIT

An organized group of adults and juveniles committed vehicle thefts and trespasses in the metropolitan area, Douglas County and Castle Rock during the last half of 2015 and as recently as January 2016. The Meadows and Red Hawk subdivisions were specifically targeted in Castle Rock. Warrants have been issued for the persons involved and arrests are being conducted. One suspect had fled to Atlanta, Georgia and was armed at the time of his arrest. The arrests cleared over a dozen cases in Castle Rock.

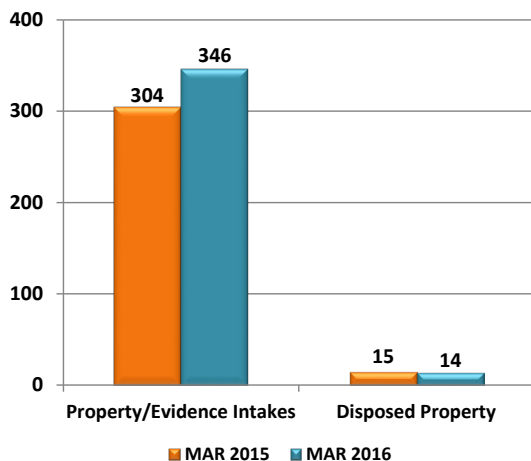

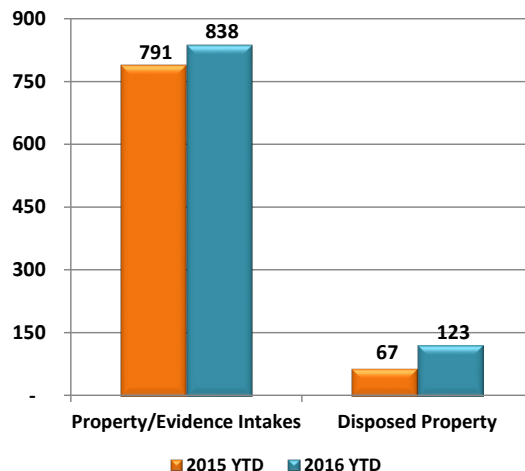

We are pleased to announce that Peggy Gorrell has joined our Victims Assistance Unit. She has expressed great excitement for this new opportunity to volunteer with our organization.

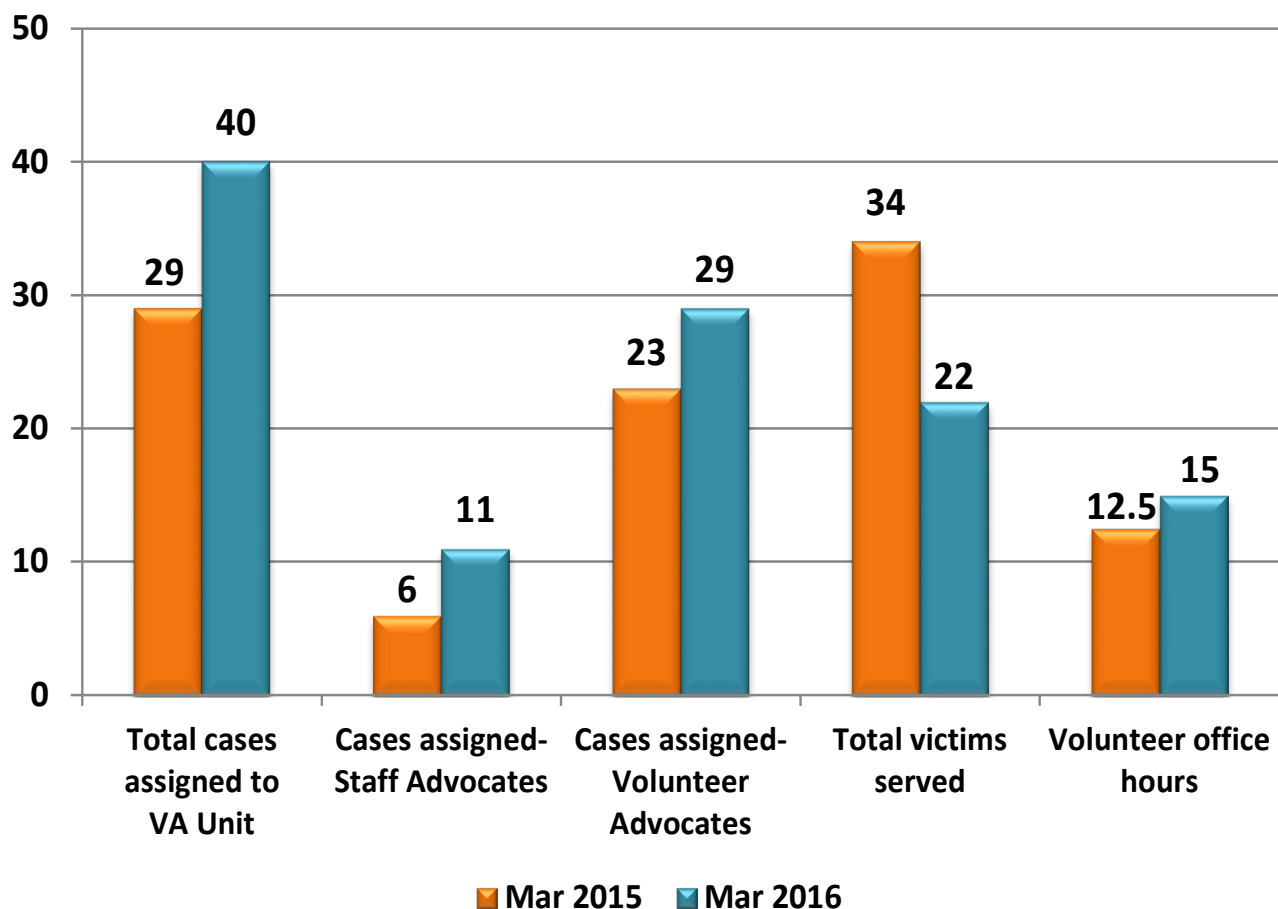

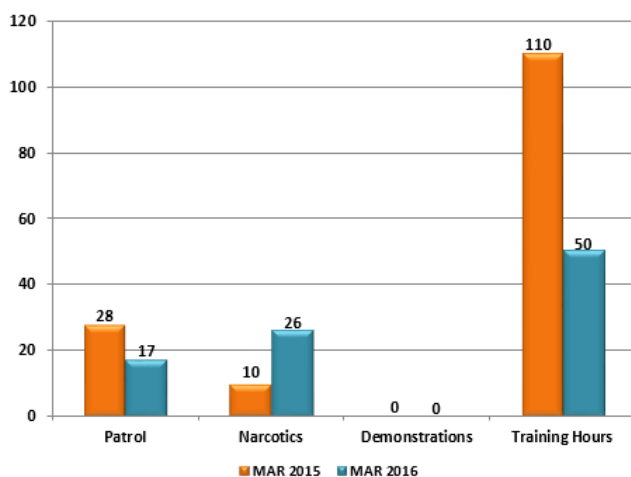

***Training** - **The K-9 Unit** provided in-service training for our Patrol Division on overwhelming force and the use of K-9s.

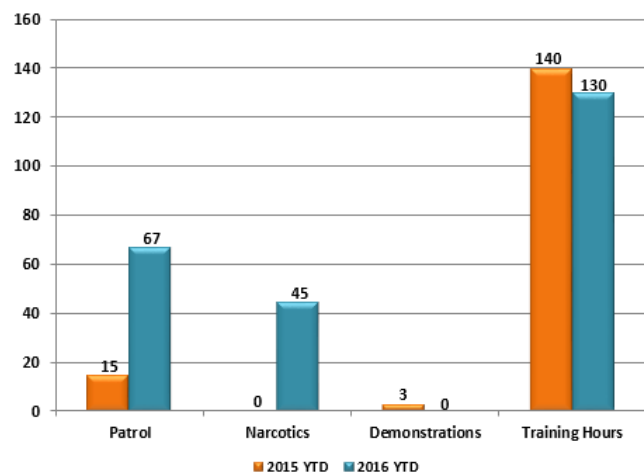

K-9 ACTIVITY: MONTHLY COMPARISON MARCH 2015/2016

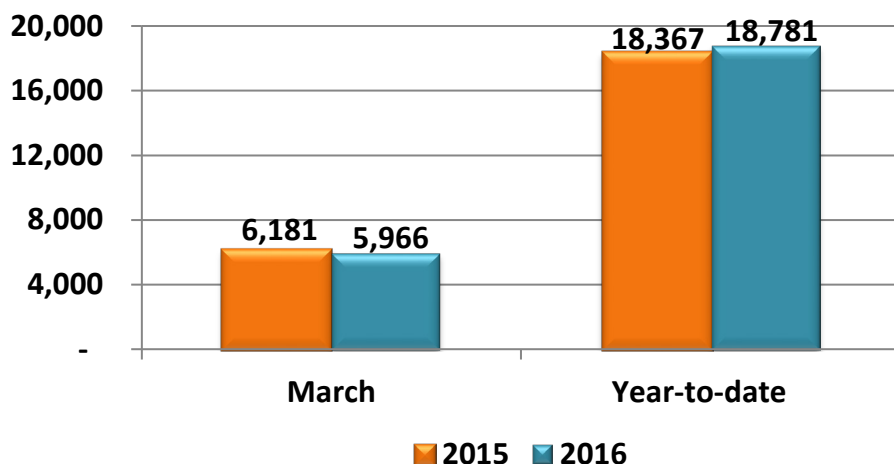


YEAR-TO-DATE COMPARISON MARCH 2015/2016

EXPLORER UNIT MARCH 2015/2016

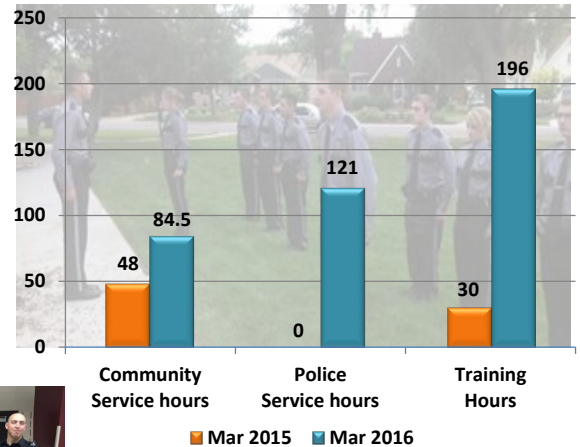
The Explorer Unit participated in the following March 25 event:

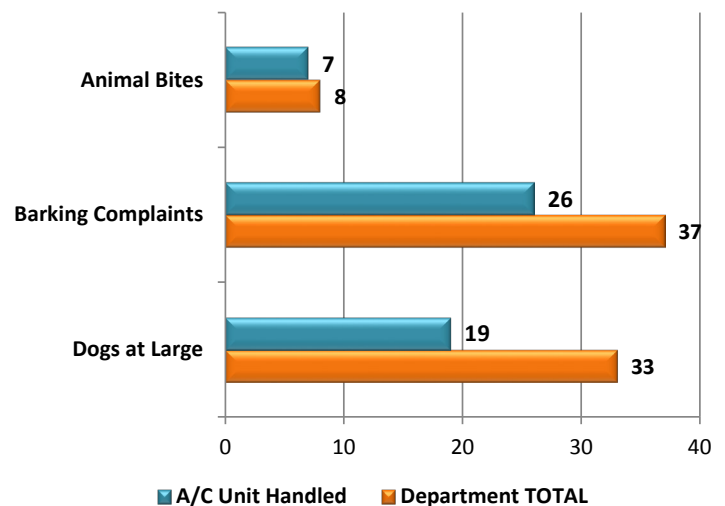

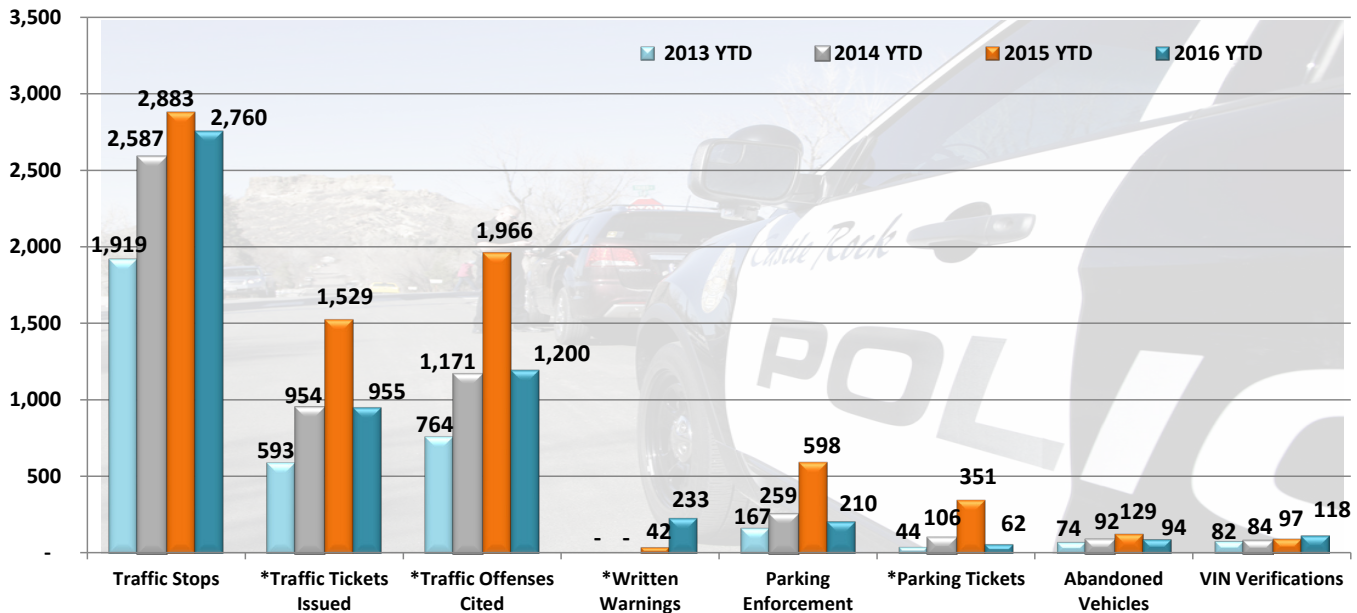
MARCH NOTES OF INTEREST FOR DDACTS

During the first quarter of 2016, CRPD stopped 2,760 suspected traffic violators and issued 955 tickets. These tickets also included accident scene violations. This means CRPD officers have given educational warnings on more than two thirds of the motorists they stop for traffic law violations.

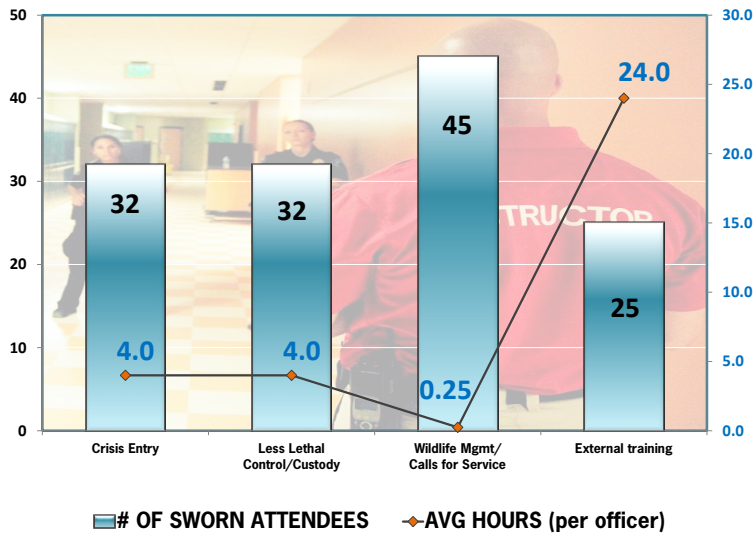

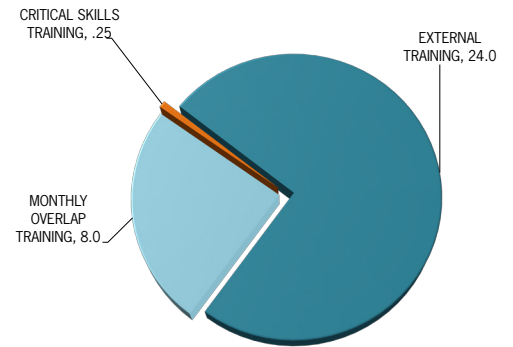

MARCH 2016

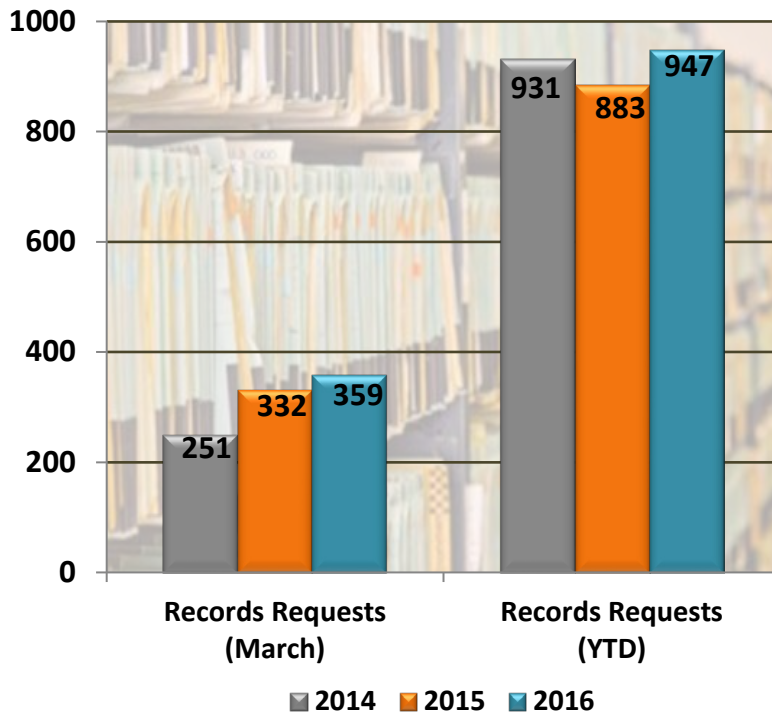


TRAINING HOURS BY CATEGORY

MARCH 2016

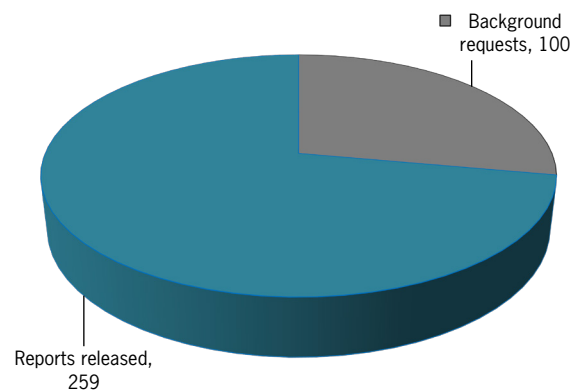


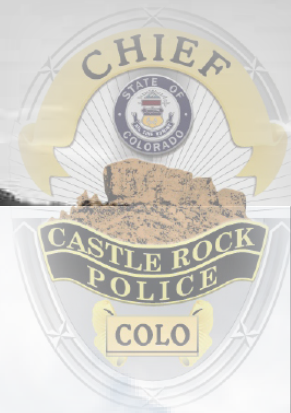
