

PROJECT BACKGROUND


- Raw water storage key factor to meet 75% renewable water supply by 2050
- CRW wants adequate storage to meet one year supply
- Site will have two reservoirs to store:
 - Reusable water supplies
 - Junior water rights on Plum Creek
 - Water supplies pumped back from Chatfield

PROJECT SCOPE

- Castle Rock Reservoir No. 1 (CRR1)
 - Currently 240 Acre Feet (AF)
 - Expansion to 550 AF
- Castle Rock Reservoir No. 2 (CRR2)
 - Construct to 790 AF
- Construction schedule: Summer 2023 Summer 2025
 - Phase I: CRR2 Construction Summer 2024
 - Phase II: CRR1 Expansion Summer 2025


