

ZONING MAP


For this area:

1985: Founders Village annexation and zoning – allowed MF (SF), IB

1994: Founders Village rezoning – MF (SF)

2015: Bella Mesa annexation and rezoning, Bella Mesa north rezoned to 525 SF homes, Bella Mesa south to 186 MF

Reduction of aprx. 900 units



SITE DEVELOPMENT PLAN

- 293.21 acres
- 525 single-family homes
- Two access connections
- Homes setbacks from mesa edge
- Sanitary service with sewer lift station



SITE DEVELOPMENT PLAN


SDP Proposal:

- 174.18 acres of open space (59.4%)
- 3.99 acre central park



BELLA MESA ZONING REQUIREMENTS

 East and north mesa edges require homes to be setback, minimum of 300 feet in most areas

Southern boundary requires equal or lesser density in two areas:



STAFF ANALYSIS

Staff finds that the proposed Site Development Plan complies with:

- Town of Castle Rock Vision and Comprehensive Master Plan
- The Bella Mesa PDP and Zoning Regulations
- Town of Castle Rock Municipal Code, Title 17.38

RECOMMENDATION

Planning Commission recommend approval with a vote of 5-2 of the Bella Mesa North Site Development Plan to Town Council.
