MEMORANDUM OF PROPERTY LEASE AGREEMENT

This Memorandum of PROPERTY LEASE AGREEMENT ("Memorandum") is made this _____ day of _____, 2022, between the Town of Castle Rock, Colorado, a home rule municipal corporation with an office address of 100 N. Wilcox Street, Castle Rock, Colorado 80104, hereinafter referred to as "Town", and Cellco Partnership d/b/a Verizon Wireless, with its principal office located at 180 Washington Valley Road, Bedminster, New Jersey 07921, hereinafter referred to as "Tenant". Town and Tenant are at times collectively referred to hereinafter as the "Parties" or individually as the "Party".

- 1. The Town is the owner in fee simple of a parcel of land located in the Town of Castle Rock, Douglas County, State of Colorado, legally described in the attached Exhibit A (the "Property").
- 2. Town and Tenant entered into a Property Lease Agreement (the "Agreement") on _______, 2022, for an initial term of five (5) years, commencing on the February 1, 2022. The Agreement shall automatically be extended for four (4) additional five (5) year terms unless the Tenant terminates it at the end of the then current term by giving the Town written notice of the intent to terminate at least six (6) months prior to the end of the then current term.
- 3. Town leased to Tenant space on the Property (the "Premises"), described in the attached Exhibit B, for the purposes of occupying and installing its communication facilities, including a non-exclusive right of ingress and egress from a public right-of-way, seven (7) days a week, twenty-four (24) hours a day, over the Property and to and from the Premises for the purpose of installation, operation and maintenance of Tenant's communications facility.
- 4. The terms, covenants and provisions of the Lease, the terms of which are hereby incorporated by reference into this Memorandum, shall extend to and be binding upon the respective executors, administrators, heirs, successors and assigns of Town and Tenant.
