2025 - 2029 SCADA MASTER PLAN UPDATE BACKGROUND

- Updated Plan projects and costs and added new sites.
- Included control system equipment & instruments and electrical system rehabilitation in projects.
- Added expanded cybersecurity focus.
- Evaluated and revised staffing recommendations.
- Identified new sites and improvements to equipment, instruments, security, communications and other infrastructure.
- Extended implementation from through 2026 to through 2029 to spread costs.

SCADA Master Plan Costs

- Spending to date (2021-2024): \$5,736,488
- Projected spending 2025 -2029: \$13,788,370
- Full implementation anticipated by 2029 with total cost of \$19,524,858
- Cybersecurity adds up to \$685k
- Each project comes to Council

2025 - 2029 SCADA MASTER PLAN UPDATE OPERATIONAL TECHNOLOGY (OT) CYBERSECURITY PROGRAM

- Castle Rock Water following #1 Guidance from USEPA, NIST Cybersecurity Framework Reduce Exposure to Public Facing Internet.
- Focused nine step plan for cybersecurity improvements.
 - All Hazards Assessment (ongoing)
 - OT Network Improvements
 - Risk management strategy
 - Incidence response, disaster recovery and continuity plans
 - Training
 - Asset management and lifecycle program
 - Change management
 - Patch management
 - Comprehensive policies and procedures
- Interlinked strategy for threat response, risk management, asset protection, regulatory compliance and operational continuity.
- Addressed immediate risks but also establishes sustainable practices for long-term resilience.

2025 - 2029 SCADA MASTER PLAN UPDATE OT NETWORK ENGINEER AND OT SYSTEMS ADMINISTRATOR

- Identified need for two Operational Technology (OT) staff who have an Information Technology (IT) emphasis.
 - ✓ OT Network Engineer: Designs and implements IT components of OT system, network, equipment and servers.
 - ✓ OT Systems Administrator: Maintains IT components of OT SCADA domain, servers, active directory and computer system.
- Positions will provide cybersecurity, update networks, and instrumentation, and ensure proper SCADA System programming, updates, and patching.
- Costs for personnel \$342,000/year and new vehicle, \$2M over 5 years.
- 1st Quarter Budget Amendment in March


