RESOLUTION NO. 2025-056

A RESOLUTION AUTHORIZING THE ENGAGEMENT OF FORVIS MAZARS, LLP, FOR THE FISCAL YEAR 2024 TOWN OF CASTLE ROCK INDEPENDENT ANNUAL AUDIT

WHEREAS, Section 9-18 of the Charter for the Town of Castle Rock (the "Town") states that the Town Council shall provide for an independent annual audit of all Town accounts by a certified public accountant or firm of such accountants who have no direct personal interest in the fiscal affairs of the Town government, or of any Councilmember, or of any other officer of the Town; and

WHEREAS, the Town Council may, without requiring competitive bids, designate such accountant or firm annually or for a period not exceeding three years, provided that the designation for any particular fiscal year shall be made no later than 30 days after the beginning of such fiscal year; and

WHEREAS, Forvis Mazars, LLP (the "Consultant"), and its predecessor, BKP, LLP, have performed the independent annual audit for fiscal years 2018 through and including 2023; and

WHEREAS, the Government Finance Officers Association guidance and industry standards recommend that municipalities enter into multi-year agreements of at least five years in duration when obtaining services of independent auditors to allow for greater continuity and to help minimize the potential for disruption in connection with the independent audit; and

WHEREAS, Town staff believes that, in order to minimize the potential for disruptions and delays in the annual audit process, it is imperative to retain Consultant to conduct the annual audit for fiscal year 2024; and

WHEREAS, Town staff desires to expand the Consultant's scope of work to include the following non-attest services: (i) assistance with the GASB 68 Town pension calculations, and (ii) assistance with the preparation of the Town Annual Comprehensive Financial Report: and

WHEREAS, the Town and the Consultant have agreed to the terms and conditions by which the Consultant will perform the fiscal year 2024 audit and the associated non-attest services.

NOW, THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF CASTLE ROCK AS FOLLOWS:

- **Section 1.** <u>Designation</u>. The Town Council hereby designates Forvis Mazars, LLP, as the Town's independent auditor for fiscal year 2024.
- **Section 2.** Approval. The Services Agreement between the Town and the Consultant (the "Agreement") is hereby ratified in substantially the same form as presented at tonight's meeting, with such technical changes, additions, modifications, deletions, or amendments as the Town Manager may approve upon consultation with the Town Attorney. The Mayor and other

proper Town officials are hereby authorized to execute the Agreement and any technical amendments thereto by and on behalf of the Town.

Section 3. First Amendment. The First Amendment to the Services Agreement between the Town and the Consultant (the "Agreement") is hereby approved in substantially the same form as presented at tonight's meeting, with such technical changes, additions, modifications, deletions, or amendments as the Town Manager may approve upon consultation with the Town Attorney. The Mayor and other proper Town officials are hereby authorized to execute the Agreement and any technical amendments thereto by and on behalf of the Town.

Section 4. Encumbrance and Authorization for Payment. In order to meet the Town's financial obligations under the Agreement, the Town Council authorizes the expenditure and payment in the amount of \$189,420.00, unless otherwise authorized in writing by the Town.
