




NEW QUASI-JUDICIAL APPLICATIONS

- Located in Mayor Pro Tem LaFleur


UNITY ON WELLSPRING NEW PLANNED DEVELOPMENT PLAN




- Planned Development Plan zoning under review, future Planning Commission and Town Council hearings

DISTRICT 2 - COUNCILMEMBER CAVEY




PROPOSED PROSPECTOR APARTMENTS TRASH ENCLOSURE




- Pre-application No formal submittal at this time

DISTRICT 3 – COUNCILMEMBER BRACKEN




PROPOSED TAFT HOUSE RENOVATIONS




- Pre-application No formal submittal at this time

PROPOSED 110 N. LEWIS ST. ADDITION




- Pre-application No formal submittal at this time

PROPOSED 310 N WILCOX ST REMODEL




- Pre-application No formal submittal at this time

PROPOSED UNITY ON WOLFENSBERGER




- Pre-application No formal submittal at this time

DISTRICT 6 - COUNCILMEMBER DIETZ




PROPOSED SITEONE LANDSCAPING EXPANSION




- Pre-application No formal submittal at this time
