### **VICINITY MAP**


- 6.43 acres

# ZONING MAP


1985 – Rezoned to Plum Creek West PD

# SITE DEVELOPMENT PLAN

- 32,826 sqft dealership and service center building
- 385 parking spaces on-site
- Maximum building height 30'
- Access on S. Wilcox with new turn lanes
- Connection to Chevy and Ford dealerships to the north

## **USE BY SPECIAL REVIEW**

Municipal Code Title 17.39

- A. Demonstrates design compatibility with the surrounding neighborhood.
- B. Demonstrates compatibility with existing and planned uses on adjacent properties.
- C. Mitigates adverse impacts or nuisance effects
- D. Will not result in undue traffic congestion or traffic hazards. Adequate off-street parking and pedestrian access must be provided.
- E. Provides adequate landscaping, buffering and screening from adjacent uses.
