Mike Hyman, Town Attorney, presented the item.

Mayor Pro Tem Cavey recalled that mill levies were capped at 60 mills. Hyman stated staff agreed to allow the max to be 70 mills because of this development. Corliss stated they also weighed that and the developer modified the site development plan to accommodate residents, which has increased their costs. They will get a completed park and changes to road and sidewalk improvements that are public improvements, but they are not extending the time.

Cavey asked what the special assessments may be. Corliss stated it will be an assessment not a mill levy.

District Council for the developer stated these assessments will not be paid by the end user. They will be paid by the builder.

Councilmember Dietz confirmed the assessments do not affect the mill levy and asked if the assessments need to come to Council. Hyman stated that is between the developer and the builder.
