# **DISCUSSION ACTION ITEMS**

National Register of Historic Places nomination of the Castle Rock Elementary School Amendment (5DA.342) located at 3rd and Cantril St. in Castle Rock, CO (Douglas County

Mr. Boland presented the update on the Cantril School, which is called the "Castle Rock Elementary" on the National Register. Staff is recommend updating the cultural survey which allows for the ability to apply for grants. The school meets 3 of the 4 criteria and potentially meets the fourth. These include: A) significant contribution (to education), B) significant persons, C) distinctive architecture and D) yielded important person(s).

Moved by Chair Beystehner, seconded by Salinas, to recommend that the Cantril School meets Criterion A of the National Register of Historic Places. The motion passed by a vote of: 5 to 0
