Good morning - We live in Sunstone Village, next to Founders Marketplace. We have reviewed the documentation provided for the proposed McDonalds and would like to express our opposition to the project.

1. The use is inconsistent with the surrounding area and businesses. There are no other fast food, let alone drive thru, restaurants anywhere near. This development belongs in higher density zoning. Currently, there are professional offices, a car wash and a 7-11. Very compatible with the surrounding area. The proposed use is incongruous with the rest of the development.

2. All existing buildings in the site area are low profile, 1 story buildings. This proposed building is over 2 stories high, with lots of glass. Prior development has been harmonious with the area and uses a lot of natural materials to maintain a low visual impact. This proposed site doesn't even come close to the feel of the surrounding area.

3. Highway 86 is already overburdened and is a 2 lane road. Traffic is heavy at the intersection of Founders and 86 and a drive thru fast food restaurant will push too much additional traffic onto the roads of that area. Everything else currently developed has minimal impact on the roadways.

4. This is a residential area, with residential support services, like the King Soopers, and other small commercial sites, to enhance local conveniences for the people who live in the area. A 5200 square foot, glass 2 story drive thru, operating late into the night does not belong in a residential community. Period.

Castle Rock has done a beautiful job of centering commercial services in denser areas close to I-25. The area of the proposed McDonalds is comprised of beautiful single or paired homes, in rolling horse country. We have wildlife, views and a controlled traffic pattern with basic support services appropriate for the area. A McMansion just doesn't fit nor belong here. We are sure there are other, more appropriately located and zoned areas for it to build. In fact, we're surprised the current zoning even allows for something like a McDonalds on this particular site.

Thank you in advance for considering our comments and we hope the planning department will take to heart what we, and many of our neighbors, feel is an inappropriate addition to the area.
