We see no provision in the ordinance that would permit full reconstruction of existing structures within the affected zone district in the event of significant or total casualty, despite the ordinance's recital that the ordinance"will not have any impact upon any development or redevelopment projects within the DOD that were previously approved by the Town.â€ânstead, it appears that the existing limitations on reconstruction of nonconforming structures currently set forth in the Municipal Code would apply. Limiting reconstruction of nonconforming structures within these new zone districts to only those circumstances currently set forth in the Municipal Code would have a direct and significant effect on those existing property owners and could have an adverse effect on the marketability and financeability of those existing projects. Secondly, I believe that the approach to height limitations set forth in the draft ordinance undermines the Town's otherwise stated desire for mixed-use development in the downtown area. The methods and means of constructing mixed-use buildings with ground floor commercial are different (and more expensive) than constructing single-use buildings. I believe that the current approach taken in the draft ordinance does not account for the cost complexities of mixed-use construction that often necessitate additional stories of development. Unless re-examined, the effects of the ordinance in its current form may well be less desirable uses that lack the ground floor commercial vitality otherwise sought by the Town and/or a complete abandonment of redevelopment opportunities by developers in the Town's downtown area. Lastly, many land owners purchased downtown properties with the current zoning in place for investment purposes. Some have a

Castle Rock hosts numerous year-round events that attract residents from all over Douglas County and beyond, with these events generating a significant economic impact for the town and the businesses that call it home. We believe that 5- and 6-story developments in the North and South Downtown zones will have an adverse impact on attendance at these events, especially the annual Star Lighting. Future 5- and 6-story developments stand to detract from the views of the Castle Rock Star and surrounding areas. In recent years as the event has grown, the Castle Rock Star Lighting has been primarily concentrated around the intersection of Fourth Street and Wilcox Street, with the main stage being there for the last several years, and previously in Wilcox Square. Obstructing the view of the Castle Rock Star from the location where most people congregate for the event will have an adverse impact on event attendance, and revenue for local business and the town itself. We believe this will spill over to other events, including the Father's Day Car Show, Fair/Rodeo Parade, and Oktoberfest, among others, but it will have the most profound, negative impact on Star Lighting, Castle Rock's biggest annual event that represents its history and what people value most about it, the community. Additionally, not having a consistent and cohesive height limit for the whole of downtown Castle Rock, as it currently stands, would be a severe detriment to Core Downtown with higher developments in North and South Downtown surrounding and obstructing th views from Core Downtown. An incohesive height limit would likely make Downtown Castle Rock feel fractured and divided.

		Another reason for our support for the new single maximum height limit of four stories is that we hope Castle Rock will grow at a more sustainable pace that is in the best interest of most of the town. Rapid growth would be in the best interest of the select few owners or "investorsâ€∄hat are interested in developing their properties in North and South Downtown. There are several excellent examples of towns that have grown at a slower, more sustainable pace, and those examples include Boulder and Aspen, both of which have height restrictions like the one the town of Castle Rock is considering. Conversely, towns that grow too quickly or unsustainably generally experience strains on infrastructure, increasing traffic congestion, and rising housing costs. Boulder, Colorado has had a historic building height moratorium capping building height at 55 feet since 1971, which helped preserve the city's views of the surrounding foothills and its character. Boulder's growth over the past 50 years has been steady and sustainable, while preserving its small-town feel. We hope that Castle Rock's growth will look like that of Boulder's, provided that the new single maximum height limit of four stories (60 feet) is supported and subsequently adopted by the Town Council. Aspen Colorado has had a 28-foot height limit for buildings since 2012, which has helped it maintain its small-town feel, as well. These two towns also serve as excellent examples of the fact that a building height restriction in the town's Downtown Core will not negatively impact property values, which is what many people who oppose this new single maximum height limit of four stories are saying. On the contrary, a new height limit of four stories will hav a positive impact on property values, as scarcity creates value.

David	Miles	Yes	The character and charm of downtown Castle Rock can be preserved by maintaining the current building height allowances while empowering the Design Review Board (DRB) to oversee setbacks, stepbacks, and architectural design. Returning more authority to the DRB would be a strong first step. Until recently, the DRB had broader influence but its scope was restricted by Town Council to buildings under 10,000 square feet. Restoring their role allows for expert oversight that encourages thoughtful development without sacrificing visual appeal or historical integrity. A blanket four-story height cap does little to foster a vibrant downtown. It restricts the flexibility developers need to pursue financially viable projects and will likely lead to more generic and less inspired buildings. Vibrancy is not achieved through restriction. It is cultivated through good design and thoughtful collaboration. Just two years ago many downtown property owners went through a similar fight to preserve the zoning and development potential that had already been granted. That effort was another attempt to roll back the town's previous vision and momentum for growth. Investors and owners made decisions based on the current rules and they deserve a sense of stability not a recurring pattern of reversals that undermine confidence and planning. Changing the rules again risks infringing on property rights and eroding trust in the process. Douglas County has assessed taxes based on this increased potential value. If that potential is stripped away owners will be paying taxes on development rights they no longer hold. This shift is unjust and sends the wrong message to those looking to invest in the long-term success of downtown Castle Rock.
