

RESOLUTION 2017-

**A RESOLUTION APPROVING A USE BY SPECIAL REVIEW FOR PERSONAL WIRELESS SERVICE FACILITIES FOR VERIZON WIRELESS AT A PARCEL OF LAND LOCATED IN THE EASTERN HALF OF THE EASTERN HALF OF SECTION 9, TOWNSHIP 8 SOUTH, RANGE 67 WEST AND SOUTHWEST CORNER OF THE SOUTHERN HALF OF THE NORTHWEST CORNER OF SECTION 10, TOWNSHIP 8 SOUTH, RANGE 67 WEST OF THE SIXTH PRINCIPAL MERIDIAN, COUNTY OF DOUGLAS, STATE OF COLORADO
(1375 WEST PLUM CREEK PARKWAY)**

WHEREAS, the Town of Castle Rock is the owner of certain property located at 1375 West Plum Creek Parkway, Castle Rock, Colorado (“Property”); and

WHEREAS, Verizon Wireless (CAW), LLC d/b/a Verizon Wireless (“Verizon”) has requested a Use By Special Review to construct three new wireless structures on the Property; and

WHEREAS, the Use by Special Review complies with the Meadows Planned Development Amendment No. 4, Zoning Regulations; and

WHEREAS, the Use by Special Review complies with the approval criteria in 17.38.050 and 17.60 of the Town of Castle Rock Municipal Code; and

WHEREAS, public hearings on the Use by Special Review have been held before the Planning Commission and Town Council in accordance with the applicable provisions of the Castle Rock Municipal Code; and

NOW, THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF CASTLE ROCK AS FOLLOWS:

Section 1. Use by Special Review Approval. The Use by Special Review for the construction of a new wireless facilities and related infrastructure at 1375 West Plum Creek Parkway, Castle Rock, Colorado, in the form attached as *Exhibit 1* is hereby approved with the following condition:

- A. The Town and Verizon enter into a Lease Agreement for the lease of the Property. The approval of the Use by Special Review shall take effect concurrently with the effective date of the Lease Agreement between the Town and Verizon Wireless.
