

2015 Successes

- Served #80 families via WRAP in 2015.
- Received referrals for WrapAround services from: Castle Rock Teen Court, Sierra Middle School, Castle Rock Elementary School, Castle View High School, Magistrates Dumler and Moss, and Child Welfare.
- Developed a WrapAround Professional Review Team, with Commander John Anderson as a member.
- Added a new program to the DCYI umbrella: 1451/Crossover.
- Obtained a \$30,000 grant from the State Dept. of Human Services.
- Increased attendance for events; 2015 Youth Congress had over 130 student participants.
- Co-hosted a Drugs in your Community event.
- Produced two informational DCYI videos.

Wrap Around Pr<u>ogram:</u>

Two Full time Facilitators and one Family Support Partner

WrapAround: How we engage families and help

- WRAP is facilitating, mediating, and coordinating family involvement with various systems, to include schools, Dev. Pathways, Community of Care Network, and Child Welfare
- WRAP works towards preventing children from entering various systems
- WRAP works towards cost savings and healthier families
- WRAP works with kids 16+ experiencing homelessness/running away, helping ensure their safety and completion of school
- WrapAround is an evidence-based process to manage care for families with complex needs who are involved in multiple systems
- We develop a collaborative plan that uses individual strengths, needs, and culture to establish family self-sufficiency



WRAPAROUND IN DOUGLAS COUNTY

- <u>**ROI**</u> On average, the cost to provide WRAP services to a family is \$3,500. At a minimum, we estimate WRAP involved families save our community \$5,000 per family served
- *Cost savings* WRAP services are saving the community money

Family #1 summary:

- 6TH Grade male
- Autism
- Referral came from school and Child Welfare
- School conflict between parents and school
- From his teacher: "one of the toughest kids I've ever worked with"
- Picked up charges for attacking his mom
- He runs away
- Need for on-going parenting skills
- Chaos in the home
- Lack of natural supports

WRAP WAS ABLE TO HELP CLOSE THE DHS CASE AND THE COURT CASE. HELPED GET SERVICES IN THE HOME; HELPED IDENTIFY SUPPORT FOR THE FAMILY; HELPED MOM WITH RESPITE; OBTAINED IN-HOME SERVICES SO PARENTS COULD LEARN EFFECTIVE PARENTING STRATEGIES



- Received WRAP referrals from school and child welfare
- Nutrition and hygiene issues with children
- Homeless cannot rent due to prior felony
- Domestic Violence in the home
- Drinking in the home
- Numerous police visits
- Male Partner has been in jail
- Unemployed
- Not engaging with the schools

WRAP helped secure temp housing; worked with schools; arranged for free basketball for oldest boy; helped interact and mediate with the schools; now working to see if family can to return to AZ for natural supports



Family #3 Summary:

- 16yo female
- Severe Mental Health and developmental disability
- 16 yo repeatedly called 911
- Numerous hospitalizations
- Significant suicidal ideation
- Possible personality disorder
- Feels unsafe in home, at school
- Mother does not have after school supervision

WRAP has held numerous meetings with all service providers to help coordinate services and treatments; coordinated with Human Services to help pay for after school care; helped get services via Developmental Pathways; helped arrange care during summer and other school breaks; helping coordinate with law enforcement on appropriate response; arranging peer support for 16 yo.

• FACES (Family and Child Engagement Services)

TEEN COURT

- DCYI helps coordinate services for juveniles in detention/court, via a program called FACES
- We work for system coordination
- We effectively intervene with youth and their families involved in the juvenile justice system
- DCYI is helping implement Teen Court in Lone Tree and Highlands Ranch; currently Parker and Castle Rock have teen court programs with outstanding results
