**Human Resources** - Serves as an internal consulting resource, provides innovative programs in support of the Town's values and fosters positive work relationships.




# **Facilities Maintenance**

### **Key Accomplishments**

- In July the Facilities team completed **271** work orders including **73** preventative maintenance activities and **38** custodial inspections
- There were no emergency work orders in July
- Ongoing recruiting for open Facility Maintenance position
- Completed annual CIRSA property inspections
- Supported installation of drones for Castle Rock Police including developing the scope of work and pulling the necessary permit
- Supported the electrical service upgrade and ADA restroom renovation projects at the Cantril building both projects are planned to be completed by fall
- Supported planning and design efforts for the Fire Station #156 project as well as bunkroom/bathroom upgrades at Fire Station 155

# **Key Accomplishments**

- Replaced end-of-life cameras at Castle Rock Water
- Added network connectivity for Castle Rock Water sites
- Replaced end-of-life switches at traffic intersections
- Patched critical security vulnerabilities on Town servers


#### Addressed **402** total tickets, with an average time to resolve of **46** hours


- There were **three** emergency tickets this month, 100% of which were resolved within 24 hours (100% is the goal)
- There were **18** urgent priority tickets this month, 100% of which were resolved within two calendar days (85% is the goal)
- There were **333** medium priority tickets this month, 99% of which were resolved within 10 calendar days (90% is the goal)

### **Geographic Information Systems (GIS)**

- Addressed **31** total tickets, with an average time to resolve of **53** hours
- There were no annexations in July
- There were no zoning changes in July
- There was **one** parcel update in July (100%), which was reflected within the GIS database map within four weeks of receipt; the goal is to have 90% of parcel changes reflected within that timeframe






# **Key Accomplishments**



# **Key Accomplishments**

- HR attended **12** interview panels, totaling **25** interviews:
  - Parks Maintenance: 1
  - o PW Sr. Construction Inspector: 1
  - Accountant: 6
  - Budget Analyst: 1
  - o Revenue Supervisor: 1
  - o Fleet Technician 3
  - CRW Project Manager CIP: 1
  - Streets Maintenance Tech: 2

  - Fleet Support Tech: 1
- **Employee Orientation**: **16** new full-time employees and **8** part-time or seasonal employees came on board in July
- **Separations**: HR separated **seven** full-time employees and **10** part-time or seasonal employees in July
- Performance Evaluations: In July HR reviewed 83 performance evaluations prior to their filing to
  ensure comments are consistent with ratings and that the Town's performance management
  standards are being met

- Employee Recognition: There were eight recognitions in July
- Training and Recruitment: HR did not do any training or attend any job fairs in July

# **Youth Commission**

## **Key Accomplishments**

- 23 students applied for the Youth Commission, 13 Male, 10 female
- 18 applicants live in Castle Rock, five live outside of Castle Rock boundaries
- 12 applicants attend a Castle Rock school, eight applicants attend a school outside Castle Rock, three applicants are homeschooled
- Six high schools are represented with the following applicants from each:
  - 6 Castle View, six Colorado Early Colleges, five Douglas County, three homeschool, two Rock Canyon and one Elizabeth
- Applicants will interview on Aug. 20 and 21 and be selected and notified the following week to begin their terms in September
