#### DECA and Youth Commission Spikeball Fundraiser Tournament

This Spikeball fundraiser between the Youth Commission and DECA will be held the evening of April 19 at the Miller Activity Center from 5 PM to 9 PM. Only those ages 14 and up can participate and the Youth Commission will donate food and beverages totaling no more than \$300.00 to this event. Due to this donation, it has been requested that the Town of Castle Rock Youth Commission logo be used.

**"I move that the Youth Commission partner with DECA on the Spikeball Fundraiser at the MAC and authorize the use of up to \$300 in Youth Commission funds for concessions to be provided free to participants while promoting Youth Commission outreach at the event."**

#### Special Voting Procedures for the Rising Star Scholarship

Chair George proposed updated voting procedures for the Rising Star Scholarship. These updates include requiring that all applicant names be redacted before reviewing submitted applications. Commissioners must review the applications prior to the Youth Commission meeting so they are prepared to discuss candidate merits during the meeting. Each commissioner is required to provide input at least once, and a roll call vote will be conducted to select the top four and, ultimately, the top two candidates for the scholarship.

#### 2026 Youth Commission Recruitment Process and Potential Bylaw Update
