

RESOLUTION NO. 2024-080

A RESOLUTION APPROVING THE INTERGOVERNMENTAL AGREEMENT FOR LAW ENFORCEMENT SERVICES RELATING TO THE ENFORCEMENT OF AN ORDINANCE LIMITING THE UNLOADING OF COMMERCIALY-TRANSPORTED PASSENGERS BETWEEN THE BOARD OF COUNTY COMMISSIONERS OF DOUGLAS COUNTY, ON BEHALF OF THE DOUGLAS COUNTY SHERIFF'S OFFICE, AND THE TOWN OF CASTLE ROCK, COLORADO

WHEREAS, Section 30-11-410, C.R.S., authorizes the Board of County Commissioners of Douglas County (the "County") to contract with the Town of Castle Rock (the "Town") for the purpose of providing law enforcement by the Douglas County Sheriff's Office (the "Sheriff") within the boundaries of the Town; and

WHEREAS, Section 29-1-203, C.R.S., authorizes the Town to enter into contracts with other governmental units for services; and

WHEREAS, on April 2, 2024, the County adopted Douglas County Ordinance No. O-024-001 to limit the unloading of commercially transported passengers in unincorporated Douglas County, which ordinance was amended by the County on _____, 2024 (the "Ordinance"); and

WHEREAS, the Town, County, and Sheriff acknowledge and agree that, to ensure consistent and efficient enforcement of the Ordinance, it is in the best interest of their respective constituents to have the Sheriff assume responsibility for the enforcement of the Ordinance within the jurisdictional boundaries of the Town; and

WHEREAS, the Town, County, and Sheriff, desire to enter into an Intergovernmental Agreement for the provision of law enforcement services in relationship to the Ordinance (the "IGA").

NOW, THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF CASTLE ROCK AS FOLLOWS:

Section 1. Approval. The IGA between the County, acting on behalf of the Sheriff, and the Town is hereby approved in substantially the same form as presented at tonight's meeting, with such technical changes, additions, modifications, deletions, or amendments as the Town Manager may approve upon consultation with the Town Attorney. The Mayor and other proper Town officials are hereby authorized to execute the IGA and any technical amendments thereto by and on behalf of the Town.
