

**RESOLUTION NO. 2023-**

**A RESOLUTION APPROVING THE CONSOLIDATED SERVICE PLAN  
FOR VALLEY VIEW METROPOLITAN DISTRICT NOS. 1-3; AND  
AUTHORIZING THE EXECUTION OF AN INTERGOVERNMENTAL  
AGREEMENT BY AND AMONG THE TOWN OF CASTLE ROCK AND  
SAID DISTRICTS**

**WHEREAS**, on March 7, 2023, the Town Council for the Town of Castle Rock (the “Town”) adopted the following ordinances:

- (i) Ordinance No. 2023-001 annexing approximately 409.008 acres of land located east of Founders Parkway, north of Crimson Sky Drive, and West of Castle Oaks Drive (the “Property”), pursuant to an annexation petition submitted by Canyons South, LLC (the “Owner”);
- (ii) Ordinance No. 2023-002, approving the Owner’s application for the initial zoning of the Property as Planned Development zoning and adopting the Canyons Far South Planned Development Plan and Zoning Regulations (the “Planned Development Plan”) to govern the future development of the Property; and
- (iii) Ordinance No. 2023-003, approving the Canyons Far South Development Agreement between the Town and the Owner (the “Development Agreement”), and vesting the Planned Development Plan as a site-specific development plan through December 31, 2037; and

**WHEREAS**, Section 3.01 of the Development Agreement acknowledges the Owner’s intent to form one or more metropolitan districts, and to submit a request to the Town for the review and approval of a service plan for such districts in compliance with the Colorado Special District Act, Section 32-1-101, et seq., C.R.S., Chapter 11.02 of the Town Municipal Code, and the Model Service Plan adopted by the Town Manager and on file with the Town Clerk: and

**WHEREAS**, Section 3.01 of the Development Agreement further acknowledges that, subject to approval of the service plan by the Town Council, the Town and districts shall enter into a master intergovernmental agreement addressing all operational aspects of the districts’ assumption of Owner’s obligations under the Development Agreement; and

**WHEREAS**, in accordance with the provisions of Section 31-12-113, C.R.S., annexation of the Property has taken effect as of April 6, 2023, thereby giving the Town Council the requisite jurisdiction under Section 32-1-204.5, C.R.S., to review any service plan submitted for the Property; and

**WHEREAS**, as a result, a Consolidated Service Plan (the “Service Plan”) for Valley View Metropolitan District Nos. 1-3 (the “Districts”) has been submitted to the Town for review and approval by the Town Council; and

**WHEREAS**, the Service Plan has been reviewed by Town staff and a public hearing held in accordance with the Special District Act, §32-1-101, et seq., C.R.S., and Chapter 11.02 of the Town Code; and

**WHEREAS**, the Town Council finds that the Service Plan generally complies with the Town's Model Service Plan and meets the requirements set forth in Section 11.02.150 of the Town Code; and

**WHEREAS**, the Town Council further finds that the Service Plan, as required by §32-1-203(2), C.R.S., establishes that:

- (i) There is sufficient existing and projected need for organized service in the area to be serviced by the Districts;
- (ii) The existing service in the area to be served by the Districts is inadequate for present and projected needs;
- (iii) The Districts are capable of providing economical and sufficient service to the area within their proposed boundaries;
- (iv) The area to be included in the Districts does have, and will have, the financial ability to discharge the proposed indebtedness on a reasonable basis;
- (v) Adequate service is not, and will not be, available to the area through the Town, Douglas County, or other existing municipal or quasi-municipal corporations, including existing special districts, within a reasonable time and on a comparable basis;
- (vi) The facility and service standards of the Districts are compatible with the facility and service standards of the Town;
- (vii) The Service Plan is in substantial compliance with the Town's Comprehensive Master Plan;
- (viii) The Service Plan is in compliance with any duly adopted Town, regional or state long-range water quality management plan for the area; and
- (ix) The creation of the Districts is in the best interests of the area proposed to be served; and

**WHEREAS**, the Town Council deems it to be in the best interests of the Town and its taxpayers, residents, and property owners to enter into an Intergovernmental Agreement setting forth the respective rights, responsibilities, and obligations of the Town and the Districts with respect to the property served by the Districts (the "IGA").

**NOW, THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF CASTLE ROCK AS FOLLOWS:**

**Section 1. Service Plan.** The Consolidated Service Plan for Valley View Metropolitan District Nos. 1-3 is approved in substantially the same form attached as ***Exhibit 1***, with such technical changes, additions, modifications, or deletions as the Town Manager may approve upon consultation with the Town Attorney.

**Section 2. Intergovernmental Agreement.** The Intergovernmental Agreement between the Town and Valley View Metropolitan District Nos. 1-3 is approved, in substantially the same form attached as ***Exhibit D*** to the Service Plan (*see **Exhibit 1***), with such technical changes, additions, modifications, or deletions as the Town Manager may approve upon consultation with the Town Attorney. The Mayor and other proper Town officials are hereby authorized to execute such agreement and any technical amendments thereto by and on behalf of the Town.

**Section 3. No Representation.** The Town's approval of the Service Plan does not in any manner constitute a representation by the Town that the Districts will necessarily achieve the development and financial projections set forth in the Service Plan.
