**A JOINT RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF  
DOUGLAS COUNTY, THE TOWN COUNCIL OF CASTLE ROCK, THE CITY  
COUNCIL OF LONE TREE, AND THE TOWN COUNCIL OF PARKER IN SUPPORT  
OF HISTORIC COUNTYWIDE PARK AND RECREATION INVESTMENTS**

*WHEREAS*, the Board of County Commissioners of the County of Douglas, in partnership with the Town of Castle Rock, City of Lone Tree, and Town of Parker (collectively “the County and Municipalities”) adopts this resolution to provide for the health, safety, and welfare of Douglas County residents, businesses, and communities.

*WHEREAS*, the County and Municipalities recognize Douglas County as a uniquely beautiful and vibrant community. The County and Municipalities are committed to providing for the continued collective advancement of Douglas County, including an unmatched park and recreation system.

*WHEREAS*, Douglas County residents have consistently supported the Parks, Trails, Historic Resources and Open Space Sales and Use Tax, which provides a dedicated 0.17% sales and use tax to fund parks, trails, historic resources, and open space.

*WHEREAS*, in response to significant public demand for additional sports fields and recreational opportunities, Douglas County is making a historic investment in parks:

**High Note Regional Park in Lone Tree** - The County shall invest \$7.5 million of parks funds to construct Phase 1 of High Note Park in Lone Tree. This portion of the 80-acre regional park will include new multipurpose fields that can be striped for up to 15 fields of play.

**Salisbury Regional Park in Parker** – The County shall invest \$7.5 million in parks funds, to contribute to the construction for the Phase 1 expansion of Salisbury Regional Park, which will include four new lighted baseball/softball fields, two new lighted synthetic turf multi-purpose soccer fields, restrooms, shelter, parking and landscaping; and will accelerate the Phase 2 expansion, which will include tennis and pickle ball courts and additional parks facilities.

**Gold Crown Fieldhouse in Castle Rock** – The County shall invest \$7.5 million of parks funds which will be matched by private investors to construct the Gold Crown Fieldhouse, a 65,000 square foot facility. The state-of-the-art complex will feature six basketball courts and twelve overlapping volleyball courts.

**Zebulon Regional Park** – The County in collaboration with community and private partners is committed to the construction of Zebulon Regional Park. Zebulon Regional Park will be a one of a kind parks and recreation experience unlike any other park in Colorado, including baseball/softball fields, multi-purpose soccer fields, multiple indoor ice rinks suitable for competitive hockey, and a recreation center that will house multiple gyms and indoor volleyball/basketball courts. Zebulon will be a destination park for families and sports enthusiasts.

**WHEREAS**, this Resolution is being adopted jointly by the Douglas County Board of County Commissioners, the Lone Tree City Council, the Parker Town Council, and the Castle Rock Town Council.

**BE IT RESOLVED**, by the Board of County Commissioners of the County of Douglas, in partnership with Castle Rock, Lone Tree and Parker, to commit to a historic investment in parks and recreational facilities in Douglas County, to meet the demands of Douglas County residents, provide for the mental and physical health of County residents, support local businesses, and provide another unique feature to the indomitable Douglas County community.
