TOWN COUNCIL UPDATE

Town Council Liaison Hollingshead updated the Board the Council has seen initial plans for Brickyard, Dawson's Trails, and other large developments. Parks and Recreation has presented and Town Council approved funding to build bike paths connecting the Miller Activity Center to Downtown Castle Rock. Additionally, the Canyons Far South project is underway. Town Council is considering budget adjustments due to a downturn in revenues. The Crystal Valley Parkway Interchange is on schedule, and the 4 corners intersection where 5th Street, Founders Parkway, Ridge Road, and Highway 86 intersect is under construction currently.

Mr. White presented an update to the Board on the August contractor luncheon topics of site cleanliness, erosion control, and Landscape and Irrigation permits. Mr. White also presented on current building permit statistics. While residential permitting has remained low, commercial activity is still performing well. Mr. White provided updates on several large commercial developments in the Town, and on the progress of the new electrical code adoption. Board Member Akaya asked for clarification on the 5-year average numbers for commercial permits, Mr. White responded. Town Council Liasson Hollingshead provided some clarification to the Board about Council's hopes for residential permitting activity is down, residential miscellaneous permitting for things like decks and remodels is experiencing high activity.
