### **COUNCIL COMMENTS**

Mayor Gray congratulated his wife on running in the recent Boston Marathon.

#### **QUASI JUDICIAL HEARINGS**

Resolution Approving a Site Development Plan for a Single Family Residential Housing Project Known as Avilla at Founders Village (Bella Mesa Filing No. 1, Tracts B and C) [located at the north west corner of Mikelson Blvd and Mitchell St.]

Councilmember Brooks recused himself from the hearing at 6:32 pm. returning to the meeting at 7:15 pm.

Tara Vargish, Director or Development Services, identified the subject property to be located near Mikelson Boulevard and Mitchell Street near Mesa Middle School. The property is 9.3 acres and the applicant proposal is for 105, single story, for rent homes, in a multi family design concept.

Applicant, Greyson Konkel, NexMetro Communities discussed the importance of this housing option to be made available in Castle Rock. The proposed community allows people to live a lifestyle within their means as well as allows for flexibility when options change. This community will provide options to a mix of young professionals to include those that work remotely, are contract

professionals, mid-age people in transition or downsizing or those wishing to age in place. The community is suitable to those who do not wish to deal with maintenance issues.

Kayleigh Robinson and Ty Robbins with Norris Design also addressed Council.

#### **ADVERTISED PUBLIC HEARINGS & DISCUSSION ACTION ITEMS**

### DIR 2023-012 Discussion/Direction: Sign Code Amendment Update and Weekend Sign Removal Discussion

Vargish, presented an update of the sign code under Title 19 of the Municipal Code. Over the years there have been various amendments to the ordinance, most recently in 2016. Staff has studied and evaluated the current code and anticipates a proposed updated to the ordinance in 2023.

It was noted that currently, per the municipal code, the Town does prohibit signage within public right of ways regardless of content. Currently enforcement of the sign code is accomplished during the typical work week, Monday through Friday, 8 am. to 5 pm. by the zoning inspectors based on complaints. Signs that are removed from the right of way are then disposed of.

Moved by Councilmember Brooks, seconded by Councilmember Dietz, to Direct staff to increase sign code enforcement to include weekends, after a period of community engagement of no less than three weeks. The motion passed by a vote of:

### DIR 2023-013 Informational Item Pertaining to the Proposed Senate Bill SB23-267 Concerning Protecting Water Quality in Chatfield Reservoir and the Watershed

Mark Marlowe, Director of Castle Rock Water, provided update on Senate Bill 23-267 designed to raise money from recreational users of Chatfield Reservoir to improve water quality issues in Chatfield Reservoir as well as upstream of Chatfield. The proposed bill includes a fee of one dollar per day for entrance at Chatfield State Park for five years, similar to the fees collected at Cherry Creek State Park.

Marlowe also added his comments in opposition to House Bill 23-1282 in regard to local authority defense of consumer claims which Council endorsed.

#### <u>RES 2023-055</u> **Resolution Approving a Design Consultant Agreement with Burns & McDonnell Engineering Company, Inc.** [*Plum Creek Water Purification Facility Expansion Project, 1929 Liggett Rd., Castle Rock, CO 80109*]

Marlowe introduced the Plum Creek Water Purification Facility expansion design contract to increase the capability to treat surface water, groundwater, and re-use water. PCWPF is recognized as one of the most advanced purification facilities in the country. The expansion will double the capacity to 12 million gallons per day. Construction is anticipated to be completed by end of year 2026.
